Nan Baker asked how much was invested in Phase 1; asked if this will be the most that will be requested to invest in this venture; asked with such a large investment, what guarantees that the County have with seeing a return on the investment; asked what happens when everything falls apart; asked what is the typical outcome on investment; asked will royalties be received over the life of the product; stated that NASA has struggled with breaking into the market so this seems hopeful in making them more successful; stated that there seems to be a lot of unknowns but it seems to look good on the outside to open the County for many other opportunities. Dale Miller asked at what point should a tentative agreement be expected; asked will there be some knowledge of what is going to happen after 16 weeks.
