II – REVIEW MINUTES – 5/16/2022

Michael Chambers motioned to approve the minutes from the May 16, 2022 meeting; Dale Miller seconded. The minutes were approved by unanimous vote, as written.

BC2022-312

Department of Public Works, requesting to amend Board Approval No. BC2021-354, dated 7/12/2021, which approved an award on Purchase Order No. 21001714 to Interior Supply Inc. for the purchase of materials for the Jail 2 Kitchen Ceiling Project, **by changing the not-to-exceed amount from \$16,517.60 to \$18,154.36.**

Tom Pavich and Nichole English, Department of Public Works, presented. Dale Miller why was there not an agreement on the original pricing; asked for follow up on whether the Purchase Order terms and conditions contains language that allows the vendor to pass along price increases to the customer, due to market changes or delays, resulting in higher prices; asked for follow up for more detail on this purchase order and whether there are any recommended changes for these types of situations. Paul Porter said he would need to review the Purchase Order's terms and conditions and follow up with the Board members; and said that this is unusual as pricing is held on purchase orders and that delays may have compounded the issue. Nan Baker said she understands the circumstances under the current financial environment, but this example could be a slippery slope where the County enters into an agreement and then it becomes the expectation that anything entered into is compromised on pricing and we must be cautious; and said that contracts we have entered into now have a potential increase built in, but anything done earlier should be looked at. Michael Chambers asked if the Board members would like to hold this request until the Board's questions have been addressed. Ms. Baker said she is comfortable with this request going forward. Dale Miller concurred with Ms. Baker but would like additional information. James Boyle said that the reality is that the County must accept price increases and absorb the added cost after a product or service has been quoted, but do not see the benefits when prices decrease; said that moral claims are based on the right thing to do and are not legally-based and that vendors do not always have the same moral claim as government; said that he agrees with Mr. Miller and Ms. Baker's recommendation that this item advance for approval; and said that the process needs to be reviewed to address this type of situation so that purchase orders can be processed more quickly. Mr. Miller said the process should be reviewed as it should not take 30 days to process a purchase order. Mr. Chambers and Mr. Porter agreed that it does take longer due to government procurement requirements that must be met to process a purchase order for Board approval but will look at potential ways to streamline the process. Michael Chambers motioned to approve the item; James Boyle seconded. Item BC2022-312 was approved by unanimous vote.
