### 1. CALL TO ORDER

Chairman Sweeney called the meeting to order at 3:03 p.m.

# 2. ROLL CALL

Mr. Sweeney asked Deputy Clerk Carter to call the roll. Committee members Sweeney, Miller and Schron were in attendance and a quorum was determined. Committee members Simon and Jones were absent from the meeting. Ms. Turner was also in attendance.

[Clerk's note: Per Council Rules 12F, Ms. Turner was appointed as a member Pro Tem of the Council Operations, Intergovernmental Relations & Public Transportation Committee.]

### 3. PUBLIC COMMENT

Loh addressed the Committee regarding various agenda and non-agenda items.

4. APPROVAL OF MINUTES FROM THE APRIL 4, 2023 MEETING

A motion was made by Mr. Miller, seconded by Mr. Schron and approved by unanimous vote to approve the minutes from the April 4, 2023 meeting.

5. MATTERS REFERRED TO COMMITTEE

a) <u>O2023-0009</u>: An Ordinance amending Section 505.03 of the Cuyahoga County Code to provide that Wage Theft committed by current or prospective contractors shall be grounds for debarment; and declaring the necessity that this Resolution become immediately effective.

Mr. Miller introduced a proposed substitute to Ordinance No. O2023-0009. Discussion ensued.

Mr. Michael King, Special Counsel, addressed the Committee regarding Ordinance No. O2023-0009. Discussion ensued.

Committee members asked questions of Mr. King pertaining to the item, which he answered accordingly.

A motion was then made by Mr. Miller, seconded by Mr. Schron and approved by unanimous vote to accept the proposed substitute.

Mr. Andre Daley, representing Guardians for Fair Work; Ms. Nora Kelly, representing the Northeast Ohio Worker Center; Mr. Brian Pearson, Legislative Policy Director for the Northshore AFL-CIO; Mr. Michael Shields, Researcher for Policy Matters Ohio; Mr. Victor Manolache, Assistant Law Director; and Ms. Alexa Beeler, Inspector General, addressed the Committee regarding Ordinance No. O2023-0009. Discussion ensued.

Committee members asked questions of Mr. Daley, Ms. Kelly, Mr. Pearson, Mr. Shields, Mr. Manolache and Ms. Beeler pertaining to the item, which they answered accordingly.

On a motion by Mr. Miller with a second by Ms. Turner, Ordinance No. O2023-0009 was considered and approved by a majority roll-call vote of 3 yeas and 1 nay to be referred to the full Council agenda for second reading, with Mr. Schron casting the only dissenting vote.
