1. CALL TO ORDER

Chairman Sweeney called the meeting to order at 3:06 p.m.

2. ROLL CALL

Mr. Sweeney asked Deputy Clerk Carter to call the roll. Committee members Sweeney, Miller and Schron were in attendance and a quorum was determined. Committee member Simon entered the meeting after the roll call was taken. Committee member Jones was absent from the meeting.

3. PUBLIC COMMENT

4. APPROVAL OF MINUTES FROM THE SEPTEMBER 19, 2023 MEETING

A motion was made by Mr. Schron, seconded by Mr. Miller and approved by unanimous vote to approve the minutes from the September 19, 2023 meeting.
