



## **Cuyahoga County Council – Procedures for Public Comment at Council and Committee Meetings**

- Requests to speak must be submitted in writing **prior** to the scheduled meeting start time on the Request Form provided by the Clerk immediately prior to each meeting.\*
- Request Forms must be submitted in-person and may not be submitted on behalf of others (one per person).
- A maximum of thirty speakers will be selected at random during the public comment section at each meeting.
- Each speaker will receive two minutes to address the council or committee. A bell will ring to signal that speaking time has ended. Speakers may not yield their time to others.
- In lieu of verbal public comment, written testimony may be submitted to Council or the applicable committee through the Clerk of Council at [CouncilPublicComment@cuyahogacounty.us](mailto:CouncilPublicComment@cuyahogacounty.us) prior to the adjournment of each meeting.

**WHEREAS**, the County and Gilbane Building Company entered into Contract No. 4263 effective April 23, 2024 for design-build services for the County Central Services Campus (“Contract”); and

**WHEREAS**, the parties now desire to amend the Contract prior to the GMP Amendment to expand the scope of Early Release Work and increase the allowance for Early Release Work Packages by the amount of \$25,000,000.00, for a total not to exceed amount of \$58,353,000.00; and

**WHEREAS**, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:**

**SECTION 1.** That the Cuyahoga County Council hereby approves an amendment to Contract No. 4263 with the Gilbane Building Company dated April 23, 2024 for design-build services for the County Central Services Campus to expand the scope of Early Release Work and increase the allowance for Early Release Work Packages by the amount of \$25,000,000.00, for a total not to exceed amount of \$58,353,000.00 effective upon signature of all parties.

**SECTION 2.** That the County Executive is authorized to execute the amendment and all other documents consistent with this Resolution.

**SECTION 3.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council, it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

**SECTION 4.** It is found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**WHEREAS**, the County and Alliant Insurance Services Inc. entered into Contract No. 5426 (fka Contract Nos. 3096 and 2698) for insurance brokerage and risk management services for the period January 1, 2023 through December 31, 2025; and

**WHEREAS**, by Resolution R2025-0321, approved December 9, 2025, the County exercised the option to extend Contract No. 5426 to December 31, 2026 and to add funds in the amount of \$2,0143,159.00 for an amount not-to- exceed \$9,166,099.00; and

**WHEREAS**, the parties now desire to amend the scope of Contract 5426 to include procurement of builder's risk and owner's protective professional indemnity insurance for construction at the County Central Services Campus and to add funds in the amount of \$3,964,000.00 for the cost of said services; and

**WHEREAS**, it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL
