1. CALL TO ORDER

Chairwoman Simon called the meeting to order at 3:05 p.m.

2. ROLL CALL

Ms. Simon asked Deputy Clerk Carter to call the roll. Committee members Simon, Stephens, Jones, Schron and Conwell were in attendance and a quorum was determined. Councilmember Turner was also in attendance.

3. PUBLIC COMMENT

There were no public comments given.

4. APPROVAL OF MINUTES FROM THE NOVEMBER 22, 2023 MEETING

A motion was made by Mr. Schron, seconded by Mr. Jones and approved by unanimous vote to approve the minutes from the November 22, 2023 meeting.

- 5. MATTERS REFERRED TO COMMITTEE
 - a) R2023-0352: A Resolution awarding a total sum, not to exceed \$50,000, to the City of South Euclid for Year Three of the South Euclid Deer Sterilization Program from the District 11 ARPA Community Grant Fund; and declaring the necessity that this Resolution become immediately effective.

Chief Joseph Mays, Chief of Police for the City of South Euclid, addressed the Committee regarding Resolution No. R2023-0352. Discussion ensued.

Committee members and Councilmembers asked questions of Chief Mays pertaining to the item, which he answered accordingly.
