1. CALL TO ORDER

Chair Adrine called the meeting to order at 2:00 p.m.

Chair Adrine then thanked Juvenile Court for attending the meeting and provided an overview of the Committee and upcoming activities.

2. ROLL CALL

Chair Adrine asked Deputy Clerk Carter to call the roll. Committee members Adrine, Yarham, Gibbons, McClelland and Cross were in attendance and a quorum was determined.

3. PUBLIC COMMENT

Ms. Nikita Stange addressed the Committee regarding the Court Appointed Special Advocates (CASA) program.

Ms. Leah Winsberg addressed the Committee regarding recommendations sent to the Committee from the Office of the Public Defender.

4. APPROVAL OF MINUTES FROM THE OCTOBER 28, 2024 MEETING

A motion was made by Mr. Cross, seconded by Ms. Yarham and approved by unanimous vote to approve the minutes from the October 28, 2024 meeting.

5. OLD BUSINESS

a) Discussion regarding format of final report

Ms. Gibbons stated that the Committee is currently compiling information from the previous meetings, and it will be available on the County's website. The final report will list issues and topics discussed at the Subcommittee meetings as well as recommendations from the public and other entities.

6. NEW BUSINESS

a) Conversation with members of Juvenile Court Bench

Committee members asked the Court questions regarding meeting with Court staff, wraparound services, re-entry support, indigent counsel, bindovers, funding for programs and oversight of private youth centers. Discussion ensued.

The Judges recommended that the Committee speak with law enforcement officers in addition to meeting with Court staff. The Judges also discussed the various barriers facing juvenile offenders, the Re-entry docket, probation issues, gun violence, Marcy's law and Corrective Action Plans (CAP). Discussion ensued.

Chair Adrine thanked the Court for hosting the meeting and participating in the discussion.

b) Schedule additional interviews and meetings with other constituent groups & individuals

Chair Adrine stated that additional meetings and interviews with constituent groups will be scheduled at another time.

7. MISCELLANEOUS BUSINESS
