1. CALL TO ORDER

Deputy Clerk Carter called the meeting to order at 9:12 a.m.

2. ROLL CALL

6. EXPLANATION AND PURPOSE OF SUBCOMMITTEE

Councilman Gallagher thanked the Committee members for volunteering and explained the purpose of the Subcommittee. Discussion ensued.

Committee members Adrine and Cross asked questions regarding the role of the Subcommittee and commitment from Juvenile Court. Discussion ensued.

Ms. Gibbons answered questions regarding the commitment from Juvenile Court and utilizing feedback from the community. Discussion ensued.

7. ELECTION OF OFFICERS

Mr. McAleer explained the process and Councilman Gallagher conducted the election for the Chair and Vice-Chair of the Committee.

a) Chair

A motion was made by Mr. Cross and seconded by Ms. Gibbons to nominate Ms. Yarham as Vice-Chair. The motion was unanimously approved.

Councilman Gallagher then congratulated the newly elected officers and then turned the meeting over to Chair Adrine.

8. DISCUSSION OF MEETING SCHEDULE

Ms. Gibbons: programming, diversion and root causes of detention

Mr. Cross: process and bindovers

Judge McClelland: assigned counsel and probation

Ms. Yarham: early intervention and diversion programs

Chair Adrine asked questions regarding the scope of work for the Committee and Ms. Gibbons discussed providing data, visual maps and other resources from the Court to the Committee. Discussion ensued.
