Happening in District 7: Public Works Projects

The warm season is upon us, so you know what that means—orange traffic cones! Construction season is well underway, and your County Public Works crew is working hard to keep our roads and bridges in tip-top shape. Here are some projects currently underway.

Ongoing County-Administered Projects:

- Franklin Boulevard, Irishtown Bend--\$2,149,000
- Jefferson Bridge 00.57 Rehabilitation, over NS--\$4,749,202
- Cleveland Lakefront Connector (E. 9th to E. 55th Street)--\$12,000,000

West Side Market Groundbreaking

In May, our West Side Market celebrated a significant milestone as it broke ground on a \$70 million plan to transform and reinvigorate Cleveland's historic public market. Stage 1 of the project includes construction on the East Arcade, which will become the home for all produce upon completion; infrastructure upgrades; and a complete basement overhaul to better support the 60 small businesses and 250 employees that work in the Market each day. This \$52 million stage was made possible by \$1.3 in Cuyahoga County Council funding, \$400,000 in funding from Cuyahoga County, and a host of additional public and private philanthropic partners. The East Arcade will conclude construction at the end of 2025.



Cleveland Public Market Corporation is currently raising the necessary funds to complete the remainder of the Transformation Plan, which includes the North Arcade (the future home of 10-12 new Market merchants who sell prepared local food), the Courtyard, the East Mezzanine Event Space and Balcony, and the Teaching Kitchen. Scam Alert & Scam Squad Guides_



The Ohio Bureau of Motor Vehicles (BMV) has received reports of a possible texting scam being perpetrated on Ohioans from scammers claiming to be from Ohio BMV.

Ohio residents have reported receiving text messages from scammers claiming to be from BMV

and informing the recipients that they have an outstanding traffic ticket. The text then instructs the recipient to pay immediately to avoid a license suspension. This particular scam is a phishing attempt that is being reported by drivers nationwide and is designed to trick residents into giving up personal or financial information.

Do not fall for this scam! Do not click any links, and delete the text.

To stay informed and educated about scams like these, the Cuyahoga County Department of Consumer Affairs has created a new Scam Squad Guide to help residents protect their money from scams.

This free, easy-to-read guide reveals how scams work, what scammers are really after and how to use simple strategies to fight back. Each guide comes with an action plan to help residents reach people they trust anytime they feel pressured to act fast.

The Scam Squad Guide is now available in print at various locations across the county, including all Cleveland Public Library branches.

Out in the Community

New Board of Elections Headquarters Now Open

The Cuyahoga County Board of Elections has officially moved to the old Plain Dealer building at 1803 Superior and celebrated with a ribbon cutting last month. Last June, the Council approved a 17-year lease at the building.

This new space will address some of the problems present at the former building on Euclid Ave. and East 30th. For one, parking was a major issue. The former site had only 48 parking

spaces, meaning voters often had to park offsite and walk to the building to register or vote in-person. The new location has 700 dedicated spaces for parking, and more space for line-queueing (inside!) and general operations.


The Board of Elections now occupies the first and part of the second floor of this building, and some of the County's Health and Human Services operations will occupy the rest of the second and all of the third floor.

I am excited for the BOE staff to now call this space home, and look forward to residents taking advantage of this facility upgrade. Plus, we get to keep the BOE right here in District 7! Thanks to our County Department of Public Works for their work on this significant project.






Save the Date: Great Estates Event Coming to District 7

Great Estates Outreach Events help residents avoid unnecessary costs and delays in settling an estate by providing guidance and documents for real



Representatives from the Cuyahoga County Fiscal Office and Cuyahoga County Probate Court will be available to provide residents with a Great Estates Program Kit. The kit contains documents needed for real estate and motor vehicle title transfer. Representatives will answer questions about how to fill out and file the appropriate paperwork and will be available to process real estate affidavits on-site.


