




A Vision for District 10: Strengthening Community, Opportunity, and Infrastructure ____

In District 10, we're building a future where opportunity meets accessibility—where businesses can thrive, families have stable housing, and infrastructure supports growth. This vision is coming to life through a series of transformative initiatives that uplift our residents and create a stronger, more connected community.

It starts with economic empowerment. Cuyahoga County Councilman Michael J. Houser is proud to sponsor a Minority & Small Business **Employer Fair** with a special focus on empowering fathers and strengthening families. Held at 19th Annual Cuyahoga County Fatherhood Conference on June 13th, this event will connect local fathers, job seekers, and entrepreneurs with meaningful employment opportunities and vital community resources. By fostering connections between minorityowned businesses, workforce agencies, and father-focused organizations, we aim to provide the support and tools necessary for long-term success and economic stability. But economic success is impossible without stable housing. That's why, in partnership with Ward 5 Cleveland City Councilman Richard Starr and the County's Office of Reentry, I am hosting the **Building Pathways Home Reentry Housing Summit**—because everyone deserves a second chance. This initiative will bring together policymakers, landlords, and service providers to create more housing opportunities for returning citizens, helping them reintegrate into society with dignity and stability. We'll discuss important issues surrounding fair housing, highlight innovative solutions, share resources, and elevate the conversation around housing access, equity, and opportunity for individuals that have returned home to Cuyahoga County. If this topic is important to you, join me on **Monday**, April 28 from 9 a.m.-3 p.m. at the Cleveland State University College of Law (1801 Euclid Ave., Cleveland). Registration is required (hhs. cuyahogacounty.gov) and free parking will be available.

Support doesn't stop there. Through the **District 10 Connecting** Communities Health and Human Services Resource Fair, we are bridging the gap between residents and essential services. From healthcare to food assistance, mental health support to help with benefits, this event will connect families with the resources they need to thrive. This free event will be held Wednesday, May 14th from 5-7 p.m. at the Cleveland Heights Community Center (1 Monticello Blvd., Cleveland Heights). As we strengthen our community, we must also think about what we can do to ensure our voices are heard. Therefore, I want to let residents know that over 70,000 Cleveland voters have been assigned new **polling locations for 2025**. The Cuyahoga County Board of Elections formalized the new Cleveland ward maps last month and published detailed interactive maps on its website, which can be found by visiting boe.cuyahogacounty.gov. These changes are taking place due to factors such as building closures, construction work, parking concerns and requests from members of Cleveland City Council. But don't worry, all registered voters in Cleveland are being mailed an



information guide for the May 6, 2025 primaries that includes their new ward, precinct, voting location and election information. Make your voice heard—if you're not registered to vote or want to check your registration status, head to the Ohio Secretary of State site, ohiosos.gov.

At the heart of our community are the homes we live in, and preserving their legacy is key. That's why Council is providing American Rescue Plan Act (ARPA) funding to support the Cleveland Restoration **Society's Heritage Home Program**, empowering homeowners to restore and maintain historic properties. This program helps keep low- to moderate-income people and vulnerable senior citizens in their aging homes. The focus will be in East Cleveland for the next three years, so residents can benefit from the program's free and impartial technical assistance, advice on home improvement and



maintenance programs, and low-interest, fixed-rate financing for home renovation and rehabilitation projects. Learn more at heritagehomeprogram.org.

Finally, none of this progress is possible without strong infrastructure. Through **District 10 road and bridge** projects, we're investing in safer streets, smoother commutes, and better connectivity. These upgrades will support local businesses, improve public transit routes, and make travel safer for everyone.

Future County Administered Projects

 - o 2025—Euclid Beach Connector: \$16,000,000
- University Heights/South Euclid
 - 2027—Warrensville Center Road, Fairmount Boulevard to Mayfield Road: \$7,500,000

Together, these initiatives form a master plan that strengthens the foundation of District 10—creating opportunity, ensuring stability, and building a future where every resident has the resources to succeed. This is more than a plan; it's a commitment to the people and the progress we all deserve.
