### **ARPA Investments**

Cuyahoga County received \$239 million from the federal government through the American Rescue Plan Act (ARPA). Cuyahoga County calculated 100% of the ARPA dollars as loss of revenue under the U.S. Department of Treasury's Final Rule and deposited it into the County's General Fund. The County Executive and County Council authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County, known as the ARPA Community Grant Fund. \$66 million was evenly distributed to the 11 Council Districts. Since funds were allocated, District 1 has approved \$6 million in American Rescue Plan Act dollars to benefit the District and other County projects that are beneficial to our Cuyahoga County community. ## Taxpayer Assistance Program\_



Property taxes have increased, and this has become an added burden on many homeowners in Cuyahoga County. No one should have to make the choice of whether to pay their property taxes or their monthly medication.

The County's new Taxpayer Assistance Program can provide up to \$10,000 in one-time direct assistance to qualified County taxpayers aged 70 or older with an active delinquency. In addition to direct assistance, the program will fund housing counseling services to help ensure residents are given the tools they need to catch up on their taxes and make informed housing choices going forward.

#### To qualify for this direct assistance, the resident must:

- Maintain a primary residence in Cuyahoga County for at least 3 years
- Have an active certified delinquency on that residence
- Be aged 70 years or older
- · Have a household income of less than \$70,000 per year
- Participate in housing counseling services with CHN Housing Partners, including a counseling session, completion of a budget, and demonstration of ongoing ability to pay
- Participate in the County's EasyPay installment payment program for future taxes
- Establish a delinquent tax payment contract for any remaining delinquency

#### A few additional notes:

- Applications will be processed by CHN Housing Partners on a first-come, first-served basis.
- Applicants will be asked to complete a program application, and to provide proof of residence, income, and household membership qualification.
- Assistance is available one time per household.
- Applicants who have received prior assistance from the Ohio House Finance Agency's Utility Assistance Program are not eligible for further assistance under this program.
- Additional assistance is available by lottery following initial distributions.

# Animal Shelter Expansion Project

I was happy to attend the recent ribbon cutting celebrating our newly-expanded County Animal Shelter. This \$2.7 million investment transforms the shelter, enhancing services and programming, while providing a safe and loving environment for our furry friends.



The expansion includes space for indoor playgroups, training and meetings, new signage, new fencing and gates, and new artificial turf for outdoor dog play areas.

The Cuyahoga County Animal Shelter is one of the best county animal shelters in the county, and serves as a model to other communities. It's also where I recently adopted my dog, Yeti, from!

## New Board of Elections Headquarters -- Now Open \_



The Cuyahoga County Board of Elections has officially moved to the old Plain Dealer building at 1803 Superior and celebrated with a ribbon cutting this month. Last June, the Council approved a 17-year lease at the building.

This new space will address some of the problems in the former building on Euclid Ave. and East 30th. For one, parking was a major issue. The former site had only 48 parking spaces, meaning voters often had to park offsite and walk to the building to register or vote in-person. The new location has 700 dedicated spaces for parking, and more space for line-queueing (inside!) and general operations.

The Board of Elections now occupies the first and part of the second floor of this building, and some of the County's Health and Human Services operations will occupy the rest of the second and all of the third floor.

I am excited for the BOE staff to now call this space home, and look forward to residents taking advantage of this facility upgrade. Thanks to our County Department of Public Works for their work on this significant project.

### Scam Squad Guides.

The Cuyahoga County Department of Consumer Affairs has created a new Scam Squad Guide to help older Cuyahoga County residents protect their money from scams.

This free, easy-to-read guide reveals how scams work, what scammers are really after and how to use simple strategies to fight back. Each guide comes with an action plan to help residents reach people they trust anytime they feel pressured to act fast.
