Cuyahoga County Council is preparing to review the County Executive's Recommended 2018-2019 Biennial Budget and Capital Improvements Program. As part of the review of the County Executive's Recommended Budget, Council will be holding departmental budget hearings this Fall.

For the most part, each department, agency and elected official will be given an opportunity to address Council in the Committee of the Whole. You will be given an opportunity to provide an opening statement at the beginning of your scheduled hearing. As part of your opening statement, please provide the following information to Council:

- A brief overview of your 2018-2019 biennial budget
- Any budget reductions or elimination of existing programs, initiatives, or services included in your 2018-2019 recommended budget from your previous year's budget
- Any new initiatives or increased expenditures that were not part of your 2016 or 2017 budget, but are included in your recommended 2018-2019 biennial budget
- Any additions or reductions of personnel in your recommended budget from your previous budget
- Any issues with your 2018-2019 recommended budget and/or any additional funding requests you would like Council to consider

Please keep your opening presentation brief and related specifically to requested information above. Your opening statement should be no longer than 5 minutes to allow for discussion and follow up questions from Council. Please resist the opportunity to use the budget hearing to showcase the accomplishments of your agency. I know it is an almost irresistible opportunity, but there is just not enough time in the schedule to allow for it.

Please review the schedule below to find the date and time as to when your agency will be presenting and confirm your attendance with Jeanne Schmotzer, Clerk of Council, at jschmotzer@cuyahogacounty.us. All budget hearings will take place in the C. Ellen Connally Council Chambers located on the fourth floor of the County's Administrative Headquarters, 2079 East 9th Street, Cleveland, Ohio 44115.

If you would like to provide additional background information about your agency that's not specifically related to your recommended 2018-2019 biennial budget, please submit via email to Clerk Schmotzer prior to your scheduled hearing to allow enough time to discuss only your recommended budget during the budget hearings.

Unfortunately, it's difficult to determine how long each agency's hearing will take, but you may want to consider following the budget hearings on Council's live-streaming website so that you don't have to sit in the Chambers waiting your turn to present. We will follow the schedule in the order listed below so you can plan accordingly.

If you are planning to have a PowerPoint as part of your presentation, please provide the file electronically in advance to Clerk Schmotzer at least a day prior to your scheduled hearing. We will have the file preloaded on the Chambers computers for you to present. In addition to the electronic version, please bring at least 20 paper copies for Council and members of the public.
