- a) Update on background information – Kahlil Seren

**Mr. Kahlil Seren, Research & Policy Analyst, addressed the Committee regarding Greater Cleveland Regional Transit Authority's annual budget, ridership, future expansion, unmet transportation needs in Cuyahoga County, potential strategies to offset the loss of the Medicaid Managed Care Sales Tax, public transit advocacy groups and other revenue sources for public transportation. - b) Presentation by State Senator Michael Skindell

**The Honorable Michael Skindell, State Senator for Ohio Senate District 23, provided an overview of the State budget process, public transportation funding and general State funding issues. Discussion ensued.**

- c) Medicaid sales tax update

**Mr. Miller stated that budget submissions are due by January 31st. County Executive Budish is also contacting representatives in Columbus and advocating on behalf of the County.**

**Mr. Miller stated that the transportation budget appropriation proposal would likely be released in a couple of weeks.**

- e) Update on traffic study regarding Superior Avenue

**Mr. Feliciano stated that the study is ongoing and the results will be released to the public once it is complete.**

**Mr. Joseph Calabrese, Chief Executive Officer & General Manager of the Greater Cleveland Regional Transit Authority, addressed the Committee regarding the history, purpose and projected costs relating to the traffic study. Discussion ensued.**
