



**MINUTES**  
CUYAHOGA COUNTY COMMITTEE OF THE WHOLE MEETING  
TUESDAY, DECEMBER 8, 2020  
1:30 PM

1. CALL TO ORDER

**Council President Brady called the meeting to order at 1:31 p.m.**

2. ROLL CALL

**Council President Brady asked Clerk Richardson to call the roll. Councilmembers Schron, Conwell, Jones, Brown, Stephens, Baker, Miller, Tuma, Gallagher and Brady were in attendance and a quorum was determined. Councilmember Simon entered the meeting after the roll-call was taken.**

3. PUBLIC COMMENT

**There was no public comment submitted.**

4. DISCUSSION / EXECUTIVE SESSION:

- a) Collective bargaining matters, including:
  - i) approving an amendment to the Collective Bargaining Agreement between Cuyahoga County and the International Union of Operating Engineers, Local 18, representing approximately 7 employees in the Department of Public Works for the period 1/1/2019 - 12/31/2021 to establish the terms of the 2021 healthcare insurance and wage re-openers and to modify Articles 26 and 28; directing that funds necessary to implement the Collective Bargaining Agreement be budgeted and appropriated.
  - ii) approving a Collective Bargaining Agreement between Cuyahoga County and Graphic Communications Conference, Local 25M, affiliated with the International Brotherhood of Teamsters, covering

approximately 4 employees in the County Print Shop for the period 2/1/2021 - 1/31/2023; directing that funds necessary to implement the Collective Bargaining Agreement be budgeted and appropriated.
