1. CALL TO ORDER

Council President Jones called the meeting to order at 3:30 p.m.

2. ROLL CALL

Council President Jones asked Clerk Richardson to call the roll. Councilmembers Tuma, Gallagher, Schron, Conwell, Stephens, Simon, Baker, Miller, Sweeney and Jones were in attendance and a quorum was determined. Councilmember Turner was absent.

Council President Jones made a motion, seconded by Ms. Simon to excuse Councilmember Turner from the meeting.

3. PUBLIC COMMENT

No public comment was given.

4. EXECUTIVE SESSION

a) Collective bargaining matters, including:

- 1) approving a Collective Bargaining Agreement between Cuyahoga County Board of Developmental Disabilities and Service Employees International Union, District 1199, WV/KY/OH, The Health Care and Social Services Union, representing approximately 220 employees in various classifications in Support Administration for the period 1/1/2022 - 12/31/2024.
- 2) approving a Collective Bargaining Agreement between Cuyahoga County and the International Union of Operating Engineers, Local

18 representing approximately 9 Heavy Equipment Operators employed in the Department of Public Works for the period 1/1/2022 - 12/31/2024.

- 3) approving a Memorandum of Understanding between Cuyahoga County, the Ohio Patrolmen's Benevolent Association, representing employees in the classification of Correction Officer in the Sheriff's Department, and the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America, Region 2-B, Local 70, representing employees in the classification of Court Security Officer in the Sheriff's Department effective upon ratification by the Cuyahoga County Council through 04/01/2022, allowing for the use of Court Security Officers to work in the Cuyahoga County Corrections Center when additional corrections staffing is needed.
- 4) approving a Collective Bargaining Agreement between Cuyahoga County and Laborers' International Union of North America, Local 860, representing approximately 157 employees in the classification of Deputy Sheriff in the Sheriff's Department for the period 1/1/2021 - 12/31/2023.

b) Pending or imminent litigation.

A motion was made by Mr. Schron, seconded by Ms. Simon and approved by unanimous roll-call vote to move to Executive Session for the purpose of discussing collective bargaining matters and pending or imminent litigation and for no other purpose whatsoever. Executive Session was then called to order by Council President Jones at 3:33 p.m. The following Councilmembers were present: Baker, Miller, Sweeney, Tuma, Gallagher, Schron, Conwell and Jones.
