1. CALL TO ORDER

Council President Jones called the meeting to order at 3:33 p.m.

2. ROLL CALL

 - a) Collective bargaining matters, including:
 - 1) approving a Collective Bargaining Agreement between Cuyahoga County and United Automobile, Aerospace and Agricultural Implement Workers of America, Region 2-B, representing approximately nine (9) employees in the Cooks, Laundry & Custodial Workers classifications at the Sheriff's Department for the period 7/1/2021 6/30/2024.

- 2) approving a Collective Bargaining Agreement between Cuyahoga County and the American Federation of State, County and Municipal Employees, Ohio Council 8, AFL-CIO, Local 2927, representing approximately one (1) employee in the classification of Social Service Worker 2 in the Cuyahoga County Sheriff's Department for the period 1/1/2021 - 12/31/2023.
- b) Pending or imminent litigation.
- c) Purchase or sale of property.

A motion was made by Mr. Schron, seconded by Ms. Simon and approved by unanimous roll-call vote to move to Executive Session for the purposes of discussing collective bargaining matters, pending or imminent litigation and purchase or sale of property and for no other purpose whatsoever.
