WHEREAS, Cuyahoga County received \$239,898,257 from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, Cuyahoga County calculated 100% of the ARPA dollars as loss revenue under the U.S. Department of the Treasury Final Rule; and

WHEREAS, since all the ARPA dollars have been calculated as loss revenue, the ARPA dollars have been deposited in the County's General Fund; and

WHEREAS, the County Executive and County Council have authorized \$86 million of the ARPA dollars for community grants to benefit the residents of Cuyahoga County (the "ARPA Community Grant Fund"); and

WHEREAS, of the \$86 million for community grants, \$66 million have been encumbered for equal distribution to each County Council District; and

WHEREAS, the Cuyahoga County Council desires to provide funding from the District 7 ARPA Community Grant Fund in the amount of \$106,000 to Merrick House for the Youth Development and Leadership Program; and

WHEREAS, Merrick House estimates approximately 250 students will be served annually through this award; and

WHEREAS, Merrick House estimates approximately two permanent and temporary jobs will be created or retained through this project; and

WHEREAS, Merrick House estimates the total cost of the project is \$259,033; and

WHEREAS, Merrick House indicates the other funding source(s) for this project includes:

- A. \$81,100 from government contracts/grants;
- B. \$69,583 from foundation grants;
- C. \$1,250 from the United Way;
- D. \$1,000 from miscellaneous revenue; and

WHEREAS, Merrick House requested \$106,100 from the District 7 ARPA Community Grant Fund to complete this project; and

WHEREAS, the Cuyahoga County Council desires to provide funding in the amount of \$106,000 to Merrick House to ensure this project is completed; and

WHEREAS, this Council by a vote of at least eight (8) members determines that it is necessary that this Resolution become immediately effective in order that critical services provided by Cuyahoga County can continue to provide for the usually, daily operations of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CUYAHOGA COUNTY, OHIO:

- **SECTION 1.** That the Cuyahoga County Council hereby awards a not-to-exceed amount of \$106,000 to Merrick House from the General Fund made available by the American Rescue Plan Act revenue replacement provision for the Youth Development and Leadership Program.
- **SECTION 2.** If any specific appropriation is necessary to effectuate this agreement, the Director of the Office of Budget and Management is authorized to submit the requisite documentation to financial reporting to journalize the appropriation.
- **SECTION 3.** That the County Council staff is authorized to prepare all documents to effectuate said award.
- **SECTION 4.** That the County Executive is authorized to execute all necessary agreements and documents consistent with said award and this Resolution.
- **SECTION 5.** If requested or necessary, the Agency of the Inspector General or Department of Internal Audit is authorized to investigate, audit, or review any part of this award.
- **SECTION 6.** To the extent that any exemptions are necessary under the County Code and contracting procedures, they shall be deemed approved by the adoption of this Resolution.
- **SECTION 7.** It is necessary that this Resolution become immediately effective for the usual daily operation of the County; the preservation of public peace, health or safety in the County; and any additional reasons set forth in the preamble. Provided that this Resolution receives the affirmative vote of at least eight members of Council,

it shall take effect and be in force immediately upon the earliest occurrence of any of the following: (1) its approval by the County Executive through signature, (2) the expiration of the time during which it may be disapproved by the County Executive under Section 3.10(6) of the Cuyahoga County Charter, or (3) its passage by at least eight members of Council after disapproval pursuant to Section 3.10(7) of the Cuyahoga County Charter. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 8. PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

Merrick House is a nonprofit community center in Cleveland that provides services to support residents from birth through adulthood. Merrick House is requesting funds to enhance and expand its Youth Development and Leadership Program. The program is open to any student between the ages of 6 and 17 who wants to participate and hundreds of students from various schools throughout Cleveland come to Merrick House for programming. Afterschool Alliance, a national nonprofit focused on expanding access to out-of-school activities, identified an enormous unmet demand for afterschool and summer programming in Ohio, reporting that for every one child in programming, there are five on a waitlist. The need for youth programming continues to grow, fueling Merrick House's plan to build capacity and increase enrollment. With this grant opportunity, Merrick House will expand outreach to more schools in Cleveland and invest in an evaluation consultant to improve social and emotional programming for youth.

According to Afterschool Alliance, twenty percent of children are alone after the school day ends. Merrick House's year-round Youth Program provides a reliable place for the children of working families to go. For many, Merrick House has been one of the only places to participate in in-person programming during the pandemic. The organization knows the importance of children having a safe place to go after school and has invested in safety measures to keep its doors open.

Afterschool program sessions run from 3pm-6pm, while summer programs are offered from 8:30am-4pm. Programming takes place Monday through Friday, with themed activities for each day of the week. Students are welcome to attend anywhere from once per week to every day. Every day during afterschool and summer programs, students participate in a combination of structured activities and open recreation. In addition, participants are provided with snacks and meals, provided in partnership with a local food pantry. Programs are segmented by age group to allow for more focused programming and team building among participants.

Merrick House creates space in its Youth Development and Leadership Program plan, allowing for adaptation based on feedback from students. Investment from students in the youth programming that's delivered ensures that participants keep coming back. The Youth Development and Leadership Program is designed with the mission of Merrick House in mind, with activities that encourage and educate, empowering kids to help their neighborhood thrive. The program curriculum evolves annually to reflect current events, helping students to connect with what is happening in their community.

Program curriculum and activities are informed by Ohio's Learning Standards to support lessons kids learn in the classroom. Program topics include STEM (science, technology, engineering, math), entrepreneurship, art & music, career exploration, etc. Merrick House recently received a large grant from Microsoft to install a tech loft and computer lab for students to utilize. With this new technology, much of the youth programming at Merrick House will be adapted to incorporate STEM. There are opportunities throughout the week for program vendors to come work with the students and Merrick House will provide in-house programming as well.

Overall, Merrick House intends for students in the Youth Development and Leadership Program to develop the social and emotional intelligence that will help them succeed throughout their lives. By offering students a safe, consistent atmosphere with caring adults to guide them, Merrick House aims to help students strengthen their five competencies defined by the Framework for Systemic Social and Emotional Learning:

- Self-Awareness
- Self-Management
- Social Awareness
- Relationship Skills
- Responsible Decision-Making

IMPACT OF PROJECT:

Who will be served:

Merrick House's Youth Development and Leadership Program is designed for students in kindergarten through 12th grade and serves children in Tremont and Cleveland's West Side. Current program participants are from the following schools within Cleveland Metropolitan School District and others: Tremont Montessori, Scranton Elementary, Buhrer Dual Language Academy, Luis Munoz Marin Dual Language Academy, Robinson G. Jones Elementary, Campus International Elementary and High School, Garfield Heights Schools. Expansion of programming will recruit from Cleveland K-12 schools within 2-mile radius of Merrick House, including: Northeast Ohio College Prep, Horizon Science Academy, Paul L. Dunbar Elementary School, Orchard STEM School, The Welsh' Academy, Near West Intergenerational School Walton Elementary School.

How many people will be served annually:

Currently, Merrick House's Youth Programming serves 200 students every year. With support from the County, programming will be expanded to serve 450 students annually.

In school year 2022-23, Merrick House is planning targeted outreach to schools within walking distance of the center. This is an approach that has been used successfully in the past, and Merrick House anticipates that consistent outreach to this community will increase enrollment and engagement in its programming. Within a 15-minute walk to Merrick House, there are 6 schools and over 2,000 students. Schools include a combination of public, charter, and religious schools. Merrick House will heavily recruit within local schools as well as leave promotional materials on doors of nearby residences and in permitting businesses. In addition, Merrick House is updating its intake form for youth programming to collect more data to ensure programming is meeting their needs.

Will low/moderate income people be served; if so how:

Yes, Merrick House is a nonprofit organization that offers programming specifically for low-to-moderate-income residents. A high proportion of the youth served by this program live below the poverty line, and close to 90% of the students live in single-parent households. All of these factors contribute to youth who don't receive the empowerment and support they need to succeed. Merrick House's Youth Development and Leadership Program fills this gap, providing a safe and educational space for students to thrive. To ensure accessibility to quality after-school programming, Merrick House offers the Youth Development and Leadership Programs at no cost to youth and their families.

How does the project fit with the community and with other ongoing projects:

There is an ongoing need in Cleveland for youth programming as the public schools struggle to provide students the resources they need to excel. Chronic absenteeism is a major barrier for students in Cleveland, with students missing so many days of school that it inhibits their learning. Cleveland Metropolitan School District had an 81% attendance rate during the most recent school year, meaning one out of every five students missed a significant amount of school days.

Merrick House's Youth Program provides a safety net for these kids, offering educational year-round programming that reinforces what students are learning in the classroom.

If applicable, how many jobs will be created or retained (specify the number for each) and will the jobs be permanent or temporary:

To increase Merrick House's capacity to deliver Youth Programming to more students, the organization plans to hire part-time staff to assist with program delivery. This will be a seasonal position that is ongoing and not temporary. In addition, Merrick House plans to hire an evaluation consultant to create a foundation for measuring the impact of its programs. The consultant will be engaged temporarily.

If applicable, what environmental issues or benefits will there be:

If applicable, how does this project serve as a catalyst for future initiatives:

With funds from this grant opportunity, Merrick House plans to contract with an outside evaluation firm to establish a foundation for solid program evaluation and outcome measurements that will strengthen future programming. As a small, grassroots community organization, Merrick House has never developed a strong method for tracking outcomes in participants. Currently, programming is informed through satisfaction surveys and success is shown with individual stories and returning members. Merrick House is positioned to provide enormous social and emotional growth for students in Cleveland because of its status as a trusted resource in the community. Merrick House is committed to investing in the time, equipment, and expertise needed to provide evidence-based programming.

Merrick House has been offering Youth Programming in various forms since it was founded as a settlement house over 100 years ago. Many of the costs included in this request to enhance and expand the Youth Development and Leadership Program are one-time costs, including contracting an evaluator. One-time purchases include Please see the attached budget.

Merrick House's Youth Development and Leadership Program is supported every year through annual philanthropic support. Merrick House has substantially decreased its overall deficit, from \$100,502 in 2018 to only \$12,268 in 2020. This change is the result of a generous bequest in 2019 as well as the agency aggressively seeking government assistance during the pandemic. Merrick House is in a strong financial position to continue expanding the Youth Program after this grant has been expended.

PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

Merrick House is requesting one-time funds to invest in repairing and improving the 73-year-old community center.

Merrick House's neighborhood center, located on Starkweather Avenue, is part of Cleveland's history. However, the aging building is in need of updates to remain a safe and welcoming place for West Cleveland residents. There are two infrastructure improvements that need to be addressed immediately to ensure the safety and efficiency of Merrick House staff and clients: installation of a security system and improved electrical work throughout the building. These updates will allow Merrick House to continue providing needed social services to the residents of West Cleveland.

Merrick House's neighborhood center has been serving the community since 1949 and many of the rooms are no longer designed to accommodate the growing client population. Within its building, Merrick House hosts a childcare center, spaces for youth programming, a gym for recreational use, and classroom for adult education and parenting classes. The center also contains offices for the staff, 19 full-time and 4 part-time, who keep the agency running. Through grant funding this year, Merrick House replaced outdated fluorescent lights and key operated switches with new LED mounted fixtures and standard switches. These updates will provide more adequate and energy-conscious lighting. With funding from the County, Merrick House would finalize updates to the building's electrical system by replacing electrical panel boxes throughout the center.

In addition to electrical upgrades, Merrick House has identified a pressing need for security. Tremont, where Merrick House is located, is a relatively safe neighborhood in Cleveland, but has seen in increase in break-ins recently. The building is unoccupied most evenings and Merrick House finds itself vulnerable to theft with the new addition of a computer lab, donated by Microsoft. In addition, the center has a responsibility to keep its members safe, from the children in Early Childhood Education program to the adults earning their GED in Adult Learning classrooms. With support from the County, Merrick House plans to install a security camera at the front entrance and a security system to secure the entire building.

Finally, Merrick House is requesting funds from the County to invest in a cooling system for the center's gymnasium. The gym is utilized by all community members, from the kids who attend summer youth programs to adults who participate in evening Zumba classes. Merrick House's building lacks central air conditioning and currently uses industrial fans to keep the large gym cool. However, these fans are proving inefficient during Cleveland increasingly warm summers. Merrick House plans to purchase portable cooling systems for the gymnasium. This one-time purchase will transform the gym into a safe and comfortable space for community members to enjoy.

Merrick House serves as a neighborhood anchor and safety-net resource, providing wraparound services that address the concerns of youth, parents, families, seniors, immigrants, and the homeless in their neighborhood. The agency serves Cleveland's West Side; primarily Tremont, Clark-Fulton, Stockyards, and Brooklyn Centre; offering support to residents from birth through adulthood by infusing the community with resources to improve life in Cleveland.

Merrick House Social Settlement was established in 1919, in part to help "Americanize" immigrants by inculcating middle-class social and cultural values as bases for citizenship. By this time, Tremont had changed a good deal from its original 1850s inception as an enclave for Cleveland's wealthy citizens. After the Civil War, European immigrants flocked to the area, finding work in the booming factories and steel mills nearby. Rudimentary housing (often without running water or electricity) sprang up within walking distance of the Flats. Poverty became commonplace and working/living conditions were frequently dreadful.

Responding to the struggles facing the urban poor, reformers in England and the US had begun opening settlement houses like Merrick during the late 19th century. The first settlement house established in Cleveland was Hiram House (1896). Roughly ten such facilities were built in Cleveland and a handful (e.g., Merrick, Karamu and Alta) still survive. Unlike its counterparts, however, Merrick House was funded through the National Catholic War Council, using surplus funds from war relief. The original facility, named for Mary Merrick, founder of the National Christ Child Society, was located in a small storefront on Starkweather Avenue and West 11th Street. In 1949, the facility was largely rebuilt at the same location (the northwest corner of Lincoln Park).

Merrick House quickly became the neighborhood's go-to spot for English classes, child care, recreation, cultural programs and neighborhood clubs. In the 1950s, additional facilities were developed and, with the arrival of Puerto Rican immigrants to the area, Merrick launched Spanish-speaking programs. Under long-time director Gail Long, who served from 1972 to 2006, Merrick House also promoted the peaceful desegregation of Cleveland's public schools, helped keep Metro General Hospital a public hospital, enhanced community health by assisting with the establishment of the Tremont People's Free Clinic and Neighborhood Family Practice, and worked to maintain affordable housing in Tremont. In 1979, Merrick House helped found the non-profit Tremont West Development Corporation (TWDC)—part of a city-wide network of community development corporations (CDCs) which have played a significant role in the revitalization of Cleveland neighborhoods.

Today, Merrick House's core service areas include early childhood education, youth services, teen and adult education, recreation, community organizing, and outreach programming, including a "MomsFirst" program for at-risk pregnant women.

Workforce Development Career Pathways

This initiative was developed to address the needs of the Cuyahoga County Job and Family Services Non-Custodial Parent TANF population. According to The Center for Community Solutions in their article "Ohio's Cash Assistance Program Fails to Meet Ongoing Need," "nationwide, as of June 2020, only 1.1 million families were enrolled in TANF cash assistance, down from the historic peak of 5.1 million families who received assistance under the AFDC in March 1994," despite the COVID-19 pandemic. JCT already has a reputable record of helping individuals, as JCT serves over 500 people a year. The strength of JCT also comes from the ability to provide a full range of workforce development services for individuals with barriers from career assessment through work readiness training, leading to a job placement and post placement support. Our goal with this initiative would be to provide even more assistance Cuyahoga County and Northeast Ohio to those parents who are TANF eligible have the tools and access they need to find stable jobs in the workforce. Therefore, this program aligns with the second purpose of TANF: helping families to transition from welfare needs to sustainable job employment. It has been proven that employment is an important determinant of health. Jobs that pay a sufficient wage contribute to better health. PROJECT DESCRIPTION

REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project):

The Post Pandemic Era left many individuals severely impacted by the loss of wages, eviction, and food insecurities, just to name some of the longstanding impact issues that remain. The OHCDC focuses on the economic development of our community by investing in the social and economic outcomes through our NECCESS Initiative and workforce development training and education. Our programs serve individuals residing in the Fairfax Neighborhood and surrounding communities within Greater Cleveland providing access to quality and affordable education and job skills training to ensure a smart start to securing and maintaining gainful employment. This curriculum has been created and implemented for a specific group of Justice Impacted men and women who are provided with everyday skills and resource services to help them thrive at home, and in needed areas of their life. OHCDC'S wrap-around supportive services include addressing Food Insecurities and Healthy Eating Support, and Access to Career Assistive Services, *

OHCDC targets individuals residing in low- and moderate-income communities with a focus on helping them connect to competitive employment with livable wages to sustain their families and work. A major component of our services is to provide support in the areas of finding and maintaining adequate housing, learning about healthy eating lifestyles in order to become more productive and self-sufficient. Our programs include industry-standard practical and knowledge-based curriculum preparing individuals for entry-level positions within emerging fields. These programs include Information Technology (Google IT Tech Support Certificate Training), Supply Chain/Logistics Technology/Warehouse Training, Client Service Administrator (Insurance), and Community Healthcare Worker.

According to data compiled by The Center for Community Solutions in a report published by the Maxine Goodman Levin College of Urban Affairs, Cleveland State University in 2021, 71.0% of residents in Fairfax live at or below the poverty rate, the median household income is \$20,331 (vs. \$30,907 in the City of Cleveland), only 28.7% of residents have a High Diploma or its equivalent (vs. 32.9% in Cleveland), and the labor force participation rate is only 52.0% (vs. 59.7% in Cleveland). Based on this data, the educational and job skills training programs provided by the OHCDC are much needed and create opportunities that many Fairfax (and surrounding area) residents might not otherwise have access to. Our mission is to enhance the health and education, economic security, and wholistic well-being of the community by providing access to training, education, employment assistance, and supportive services in the neighborhood. We address the issue of unemployment and underemployment by helping individuals find and secure competitive livable wages to support the basic needs of their families, which includes housing and food. Our programs are offered below market rate or free of charge to eradicate financial barriers for individuals who would otherwise not be able to afford enrolling in similar training programs at other institutions or organizations. As mentioned, many of the situations are the direct result of the Pandemic, which left families jobless, hungry and in some instances, without housing.



PROJECT DESCRIPTION REQUEST DESCRIPTION (include the project name, a description of the project, why the project is important or needed, and timeline of milestones/tracking of the project): The Comics at the Corner Literacy Lounge serves the people in the Buckeye-Shaker, Woodland Hills, and Mt. Pleasant neighborhoods by providing pop-up-style comic book fairs in neighborhood locations. According to the Literacy Co-op's annual Literacy Dashboard, 54% of adults in Cuyahoga County are not reading proficiently. In the Mt. Pleasant area, some reports say that the number is near 90%. Literacy is not a simple issue that can be addressed using one method or by not connecting to the outlying barriers that impede access to reading. These issues include access to book ownership, financial capacity, proximity to bookstores, and availability of materials that are representative and relatable. Comics at the Corner began in late 2018 as a response to these alarming statistics. Since its inception, we've distributed nearly 5,000 comics to residents primarily in the St. Luke's footprint. Our mission is to bridge the gap between literacy and literature in underserved & underrepresented - low-literacy - communities. We do this by providing culturally relevant and representative comic books to residents, of all ages, and providing space for residents to engage with the material in authentic and community-designed ways. We call these spaces "Literacy Lounges" or "The Lit Lounge" A note about the language around literacy: You may notice that we avoid using the term "illiteracy" throughout this application. That is intentional. That term removes the societal factors that contribute to the problem and disengages from actionable and equitable solutions. Families and residents in target neighborhoods of Cleveland and southeastern Cuyahoga county that are experiencing low literacy outcomes in combination with other quality of life "co-morbidities" such as lack of access to book ownership and choice.

How many people will be served annually:

We have distributed nearly 5,000 comic books over 5 years. On average one person gets 2 books. We estimate serving at least 300-500 people through our pop-up Literacy Lounges and continued community partner events like the Buckeye Neighbors Annual Trunk or Treat Halloween event.

Will low/moderate income people be served; if so how:

Yes.

The average annual household income in MT. Pleasant sits is \$53,919, while the median household income at \$36,126 per year. Residents aged 25 to 44 earn \$36,399, while those between 45 and 64 years old have a median wage of \$41,662.

The average annual household income in Buckeye-Shaker is \$69,633, while the median household income sits at \$40,563 per year. Residents aged 25 to 44 earn \$42,000, while those between 45 and 64 years old have a median wage of \$48,872.

We specifically serve communities that have seen massive disinvestment and as a result are struggling to thrive. Unfortunately, these same people tend to be LMI, have not gotten adequate investments in education and health, and lack opportunities to access literacy and literature that is both engaging and representative.

How does the project fit with the community and with other ongoing projects:

CLE Reads is a year long commitment from the mayor's office in partnership with Cleveland Public Library to get residents reading. We have been in contact with organizers of this work and other literacy orgs like Seeds of Literacy to partner on ongoing efforts and creation of new events and engagement opportunities
