

## **PUBLIC NOTICE: CUYAHOGA URBAN COUNTY 5-YEAR CONSOLIDATED/ FY2025 ACTION PLANS**

The National Affordable Housing Act of 1990 (Housing Act) as amended and implemented through the U.S. Department of Housing and Urban Development (HUD) regulations at 24 CFR 91, requires local governments to submit both a strategic planning document, the Five-Year HUD Consolidated Plan (Plan) and Annual Action Plans. The Action Plan is an application for three programs administered by Cuyahoga County through the Department of Housing and Community Development. These programs are the Community Development Block Grant (CDBG), the Emergency Solutions Grant (ESG), and the HOME Investment Partnerships (HOME) program. The FY 2025 application enables the County to access and use new funding more than \$7,000,000.

The Housing Act also enabled the cities of Cleveland Heights, Euclid, Lakewood, and Parma to join with the Urban County to form the Cuyahoga Housing Consortium (Consortium), to submit a coordinated application for HOME funding. Each of these cities is currently developing a Five-Year Plan and Annual Action Plan for their respective jurisdictions and are conducting citizen participation processes in their communities.

### **Public Hearing #1**

Cuyahoga County will hold a public meeting to discuss and receive comments on housing, community development needs, and programs in the suburban communities served by the County's HUD programs for both the FY 2025-29 Consolidated Plan and the FY 2025 Annual Action Plan. The public hearing will be held on **Wednesday, May 14, 2025, at 10:00 AM** in the Cuyahoga County Council Committee Room B, 4<sup>th</sup> Floor, Cuyahoga County Administrative Headquarters, 2079 East 9th Street, Cleveland, Ohio 44115.
