### Emergency PRC Assistance Available for Eligible Families

Low to moderate income families impacted by COVID-19 may be eligible for help with food, essential supplies, and housing costs through emergency funding from the Ohio Department of Job and Family Services. Cuyahoga Job and Family Services is accepting applications for assistance through its Prevention, Retention, and Contingency (PRC) program. Eligibility for the COVID-19 PRC program is limited to Cuyahoga County families that include: a minor child or a pregnant individual, or a non-custodial parent of a minor child receiving Ohio Works First (OWF), Supplemental Nutrition Assistance Program (SNAP) and/or Medicaid where the income is at or below 200 percent of the federal poverty limit. Additional eligibility criteria apply.

### Cuyahoga County Issues Mask Policy for All County Buildings

Cuyahoga County has been identified as an area of "substantial spread" of COVID-19 by the Centers for Disease Control and Prevention (CDC). Based on recommendations and guidance from the CDC, Ohio Department of Health, and the Cuyahoga County Board of Health, we are adjusting our building safety requirements. Effective **Thursday, August 5**: all County employees are required to wear a mask, regardless of vaccination status, when in a common area within any County building; all County employees are required to be screened for temperature and mask-wearing; and visitors to County buildings must continue to wear masks and screen for temperature and mask-wearing.
