Property Tax Bill Deadline Extended to February 10th

The Cuyahoga County Treasury Department has extended the last day for residents to pay property taxes from Thursday, January 27, 2022, to **Thursday, February 10, 2022**. It is important to note that residents will see a payment deadline of Thursday, January 27, 2022, on the bills they received in the mail. However, the last day to pay without penalty has been extended to Thursday, February 10, 2022. There are several ways to pay your property tax bill, including by mail, online, by phone, at the drop box located on the side of the Cuyahoga County Administrative Headquarters (2079 East Ninth Street, Cleveland, OH 44115), or in person.

Are you over 60 and struggling to pay your gas or electric service bill? Ohio's Home Energy Assistance Winter Crisis Program helps income eligible Ohioans that are threatened with utility disconnection, have been disconnected, or have less than a 25 percent supply of bulk fuel in their tank maintain their utility service. Both homeowners and renters are eligible for assistance. The program runs from November 1 until March 31.
