In accordance with **County Code §701.07(C)**, we are submitting this monthly update through **May 2020**.

• General Fund Revenue:

Sales Tax receipts totaled \$19.2 million in May 2020. Through May, sales tax receipts totaled \$112.4 million, which represents a year over year increase of 4.58%.

- Attached is the new INFOR/Lawson report **YEAR-TO-DATE FUND BALANCE by FUND**, which summarizes YTD Receipts and YTD Expenditures for all the County's funds. Please note:
 - This YEAR-TO-DATE FUND BALANCE by FUND has not been audited
 - Several funds have been consolidated (ie: Casino Fund, Auto Title, Coroner's Lab, County Planning Commission have been consolidated to General Fund)
 - Subfunds have been eliminated
- Alternate Tax Budget has been submitted to County Council. This budget is required by Ohio Revised Code and demonstrates our need for property taxes levied by the County.

 - Schedule 2 estimates our resources
 - Schedule 3 detail our general obligation debt.

The Alternate Tax Budget is scheduled for the June 15th, 2020 Finance and Budget Committee.

- Sales Tax Receipts of 19.8 million have been reported for June 2020. This brings our 2020 yearto-date total to \$132.4 million. This is 12.93% less than this month last year but still 1.5% more year over year.
- The Ohio Department of Taxation forwarded partial and preliminary non-auto sales tax data for April, which is ODT's May accounting period and normally not reported and dispersed to counties until mid-July. Preliminary Sales Taxes of \$14 million have been reported for July 2020 which is 27% less than July of 2019.
- CARES Act, as of June 1, 2020 approximately \$19,855,254 in emergency purchases have been approved via Ordinance O2020-006 & Executive Order EO2020-0002. Some of the larger purchases and contracts include: \$5 million to the Board of Health for COVID-19 testing, \$8 million to the Board of Health for operational funding and \$2.1 million to Neighborhood Progress, Inc. for small business stabilization grants. The majority of the other purchases were Personal Protective Equipment (PPE).
- Anticipated Budget Reductions due to COVID-19. We continue to project 20% loss of sales tax revenue and 10% loss in property and other tax revenue for 2020. These percentages translate to approximately \$76M in lost revenue (\$53M in sales tax, \$23M in property and other taxes). As a result, we are planning to reduce expenditures by implementing a hiring freeze, 10-day furloughs and 15% budget reductions for County Executive departments. We are also working with the Non-Executive departments to implement similar measures and budget reductions.
