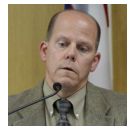

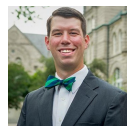

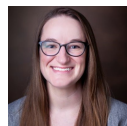

Go to selected crime scenes to become acquainted with the type of information that needs to be accumulated and the preservation of evidence.

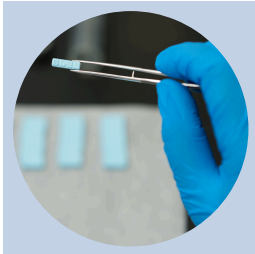


COURT PROCEEDINGS

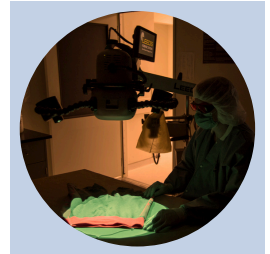

The main objective of this training program is to provide you with broad exposure to the practice of forensic pathology, from which you may gain solid, comprehensive, wholesome knowledge with the necessary skills and attitudes for this discipline. During this year of fellowship, you will be appointed as a Deputy Medical Examiner and will work with each of the on-duty professional staff, but will work most closely with the program director.

Training in forensic pathology will be a tutorial system under the direction of **Dr. Joseph A. Felo, Forensic Pathology Fellowship Program Director**, and associates. This program is designed to provide one year of training in the special field of forensic pathology to individuals previously trained in anatomic and clinical pathology or in anatomic pathology alone.
