


Data Source: CCMEO & Cuyahoga County Regional Forensic Science Laboratory (CCRFSL) accredited by the National Association of Medical Examiners.. The CCRFSL, accredited by the American Board of Forensic Toxicology, provides forensic analytical testing of specimens. The detection of substances by the laboratory may not necessarily be the ultimate cause of death as determined by the patholo gist, therefore data are provisional and subject to change. *Drug categories are not mutually exclusive, as most deaths are attributed to multiple drugs. *2025 projections based on data through March 27, 2025.





The CCRFSL is accredited by the American Board of Forensic Toxicology & the ANSI National Accredation Board.


Ranking of Top Drug Submissions from 2021 - 2024
