

THIS Contract made and entered into this _____ day of _____, 20__ by and between the County of Cuyahoga, Ohio (the "County"), and Lakefront Automotive Parts, Co., an Ohio corporation, with principal offices located at 3141 Superior Avenue; Cleveland, Ohio 44114 (the "Vendor").

WITNESSETH:

That for and in consideration of payments hereinafter mentioned, to be made by the County, the Contractor agrees to furnish all materials and labor, and perform all the work required Automotive Replacement Parts to the Department of Public Works, of Cuyahoga County, Ohio for the period: May 1, 2011 through April 30, 2013 in accordance with the specifications and to the satisfaction and acceptance of the County.

The Contractor further covenants and agrees that the following documents shall be bound with or accompany and be an essential part of this contract: Notices to bidders and proposals upon which this contract was awarded; specifications predicated to this contract; the material specifications together with the general clauses and covenants of the Cuyahoga County Executive and/or Cuyahoga County Council in effect at the time this contract is entered into; Contractor's Performance Bond; and this Contract.

It is expressly stipulated and agreed that the Contractor hereby covenants and agrees that he/she has full knowledge of the site, plans, specifications, and conditions relative to the performance contemplated by this contract and made an essential part thereof, and that the affixing of his/her signature hereto shall constitute complete acceptance of and compliance with aforesaid specifications, and conditions.

In consideration of the premises the County agrees to pay to the Contractor a certain sum of money which shall be as set forth in the proposal attached hereto and made a part hereof. This aforesaid sum shall be understood to be
NOT TO EXCEED: One-Hundred-and-Twenty-Thousand-Dollars.
