WHEREAS, in order to continue to provide the Prevent Premature Fatherhood Program amendments to Contract Encumbrance No. AG1100147-01 are necessary:

THEREFORE, the following amendments to the aforementioned Contract are agreed to by and between the parties hereto, as follows:

- 1. That the reason for this amendment is to extend the period of performance and to amend the contract amount to provide for the continuation of services.
- 2. That Paragraph I (Term) is hereby amended by extending the end date of the contract from <u>June 30, 2012</u> to <u>June 30, 2013</u>.
- 3. That the amount of the contract is amended by \$95,000.00.
- 4. That the costs incurred for salaries, fringe benefits and consultation fees are amended by \$65,165.20.

Salaries and Fringe Benefits \$45,290.63 Consultation Fees \$19,874.57

5. That the cost incurred for teen/parent family events is amended by <u>28</u> times <u>\$817.85</u> for <u>\$22,899.80</u>.

- 6. That the cost incurred for community-based forums is amended by 5 times \$1,387.00 for \$6,935.00.
- 7. That Provider billings for services rendered during the term of the original contract, July 1, 2011 through June 30, 2012, shall not exceed the dollar value of the original contract. Provider billings for services rendered during the term of this amendment, July 1, 2012 through June 30, 2013, shall not exceed the dollar value of this amendment. Any unused funds from the original contract will not carry over into the period of this amendment.
- 8. That the effective date of this amendment is **July 1, 2012**.

All other "Terms and Conditions" and EXHIBITS of the aforementioned Contract Agreement remain as originally written.
