WHEREAS, on or about December 5, 2011, the Board of Control, under Approval No. BC2011-133 awarded Contract No. CE1100688 to Allied Technology Integration, Inc. for consultant services for Public Works SCADA System; and

WHEREAS, Department of Public Works of Cuyahoga County, recommended to the COUNTY that the aforementioned services be performed by the PROVIDER, as Amendment No. 1 to Contract No. CE1100688; and

WHEREAS, the PROVIDER has agreed to the terms and conditions for the consideration indicated herein below.

NOW THEREFORE, in consideration of the mutual promises and obligations herein to be observed and performed by the parties hereto, the COUNTY and the PROVIDER hereby agree as follows:

- SCOPE OF SERVICES The PROVIDER shall provide consultant services for Public Works SCADA System.
- 2. <u>DURATION</u> The COUNTY agrees to extend the time duration of the original contract as follows:

Current Contract duration: 12/5/2011 – 12/4/2013 Revised Contract ending date – 6/4/2014

- 3. <u>COMPENSATION</u> There will be no increase in the original contract value of \$180,000.00.
- 4. ORIGINAL AGREEMENT Nothing in this Agreement shall in any way release either party from any of the obligations of the original contract or previous Amendments.

BY ENTERING INTO THIS CONTRACT I AGREE ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT. I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.
