Amendment to contract #CE 1100784-01 entered into this _____ day of _____, 2012, by and between the County of **Cuyahoga**, Cuyahoga County, Ohio (the "**County**"), on behalf of the Office of Early Childhood ("OEC") and Guidestone (transforming from Berea Children's Home and Family Services) ("**Provider**"), an Ohio nonprofit corporation, with principal offices located at 202 E. Bagley Rd, Berea, Ohio 44017 for the purpose of amending the contract to add additional funds as follows:

1. Amending Article IV, "CONTRACT VALUE" effective April 1, 2012 to read:

This amendment shall total **\$1,123.00** from an aggregated contract award amount of **\$33,595.00 to \$34,718.00**. Total expenditures shall be limited to the aggregated amounts by account/program area as outlined in the **Revised Exhibit A** (attached):


2. All other terms of the contract are hereby reaffirmed.


