PURCHASE OF SERVICE CONTRACT

EL BARRIO, INC.

AMENDMENT NO. 1

THIS CONTRACT AMENDMENT made and entered into this ____ day of _____, 2013 by and between the County of Cuyahoga, Ohio (the "County"), on behalf of Cuyahoga Job and Family Services (the "Agency") and El Barrio, Inc., a nonprofit organization with principal offices located at 5209 Detroit Ave., Cleveland, Ohio 44102, (the "Provider").

WITNESSETH:

WHEREAS, in order to continue to provide a Job Placement and Job Retention Program for OWF eligible recipients, amendments to Contract Encumbrance No. CE-1200421-01 are necessary:

THEREFORE, the following amendments to the aforementioned Contract are agreed to by and between the parties hereto, as follows:

- 1. That the reason for this amendment is to expand the statement of work and to extend the period of performance and increase the contract amount to provide for the continuation of services.
- 2. That Paragraph I (Term) is hereby amended by extending the end date of the contract from <u>June 30, 2013</u> to <u>June 30, 2014</u>.
- 3. That the statement of work is expanded to add the following job skills activity for noncore hours:

"Job Skills Training Directly Related to Employment includes general training (i.e. software courses, professional exam preparation, and business writing) that prepares an individual for employment. Activities provide an individual with the ability to obtain employment & adapt to the changing demands of the workplace and include a combination of classroom, and computer exercises."

- 4. That the amount of the contract is amended by \$579,293.00 from \$515,000.00 to \$1,094,293.00.
- 5. That the number of Job Readiness/Job Search Training and Case Management Service months is increased by 12 from 12 months to 24 months for a total of \$682,293.72. Twelve (12) JR/JS Training and Case Management Service months at \$25,750.03 and 12 months at \$31,107.78.
- 6. That the number of job placements is increased by <u>245</u> from <u>245</u> to <u>490</u> times <u>\$168.16</u> or <u>\$82,398.40</u>. Job placement payments will be made for participants who achieve this milestone by June 30, 2014.
- 7. That the number of Ninety (90) Day Job Retention payments is increased by <u>147</u> from <u>147</u> to <u>294</u> times <u>\$420.42</u> or <u>\$123,603.48</u>. Ninety (90) Day Job Retention payments will be made for participants who achieve this milestone by September 30, 2014.
- 8. That the number of participants achieving monthly participation requirements is increased by 315 from 315 to 630 times \$326.98 or \$205,997.40. Participation payments will be made for participants who achieve their work activity hours by September 30, 2014. For participants who start the program on the 1st through the 15th of the month, payments will be made to the provider for participants who achieve 100% of their 'prorated' scheduled/assigned activity hours.
- 9. That Applicable County Ordinances apply. All Contracts in which the County is a party, including this Contract, are subject to all applicable County Ordinances, including, but not limited to, the Cuyahoga County Ethics Ordinance, the Cuyahoga County Inspector General Ordinance and the Cuyahoga County Contracting and Purchasing Procedures Ordinance. During the term of this contract, including any extensions, all parties shall remain in compliance with all applicable County Ordinances and may access copies of all County ordinances on the Cuyahoga County Council's website at http://council.cuyahogacounty.us/.
- 10. That the effective date of this amendment is **July 1, 2013**.

All other "Terms and Conditions" and EXHIBITS of the aforementioned Contract Agreement remain as originally written.
