

**Amendment to Contract
CE CE1200424
by and between
Cuyahoga County
and
Avantia, Inc.**

THIS AMENDMENT (hereinafter referred to as the "Amendment") is made and entered into this ____ day of ____, 2013, by and between Cuyahoga County, Ohio ("the County"), on behalf of the Cuyahoga County Department of Information Technology and Avantia, Inc., ("Avantia"), a Ohio Corporation with office located at 9655 Sweet Valley Drive, Suite #1, Valley View, OH 44125. (the "Provider")

WHEREAS, the County and Avantia, entered into Contract CE1200424-01, for Professional IT Consulting Service, at the Department of Information Technology, for the time period of 7/2/12 – 7/1/13, in the amount of \$335,800.00; and

WHEREAS, the County desires to amend the term of its Contract with Avantia, to include additional hours in the Business Analyst Role and .NET programming role, the Business Analysts will be used to complete the ERP RFP and the .NET programmers will be used to complete phase 2 items on BOR system and to integrate GIS into the Real Property web pages. The amendment will extend the end date from 7/1/13 to 7/1/14; and

WHEREAS, this Amendment will cause an increase of the contract in the "not to exceed price" of current executed contract, in the amount of Four Hundred Eight-One Thousand Seven Hundred Dollars and Zero Cents \$481,700.00. The current "not to exceed price" shall be, Eight Hundred Seventeen Thousand Five Hundred Dollars and Zero Cents (\$817,500.00); and

WHEREAS, the County and Avantia have mutually agreed that changes are necessary, to the terms and provisions contained in the original Contract.

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, Avantia and the County agree as follows:

I - AGREEMENT AND TERM


A. The Contract, as amended, will increase the number of hours needed, in the Business Analyst and .NET programmer roles, at additional cost of Four Hundred Eight-One Thousand Seven Hundred Dollars and Zero Cents, (\$481,700.00). The term of the contract will be extended from 7/2/12 – 7/1/13 to 7/1/14


All other terms and conditions of the original contract and prior amendment thereto, which are not expressly modified herein, shall remain in full force and effect.
