THIS AMENDMENT is entered into this _____ day of _____, 2013 by and between the County of Cuyahoga, Ohio (hereinafter called the "COUNTY"), the Cuyahoga County Court of Common Pleas, Juvenile Court Division (hereinafter called the "COURT") and Case Western Reserve University, on behalf of Begun Center for Violence Prevention, at the Mandel School of Applied Social Sciences, an institute of higher education with its main offices located at 10900 Euclid Avenue, Cleveland, Ohio 44106-7167 (hereinafter called the "VENDOR").

WITNESS THAT:

WHEREAS, the COURT desires to engage the VENDOR'S professional and technical services to conduct a Juvenile Detention Utilization Study.

NOW, THEREFORE, it is agreed that the CONTRACT by and between the COUNTY, the COURT and the VENDOR for services to be rendered from January 1, 2013 to June 30, 2013 is hereby amended to include the following revision to sections:

- To extend the agreement for twelve (12) additional months, from July 1, 2013 to June 30, 2014.
- ELECTRONIC SIGNATURES - By entering into this AGREEMENT, the VENDOR agrees on behalf of the contracting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means and that the electronic signatures affixed by the COUNTY to said documents shall have the same legal effect as if the signature was manually affixed to a paper version of the document. The VENDOR also agrees on behalf of the aforementioned entities and persons to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

All other sections of the original contract shall remain the same.

IN WITNESS WHEREOF, the COUNTY, the COURT and the VENDOR have executed this AMENDMENT to the CONTRACT.
