PURCHASE OF SERVICE CONTRACT

WITH

STELLA MARIS, INC.

AMENDMENT

IN CONSIDERATION of the mutual promises contained in the Contract Agreement by and between the County of Cuyahoga, Ohio (the "County") and Stella Maris, Inc., a corporation not-for-profit, with principal offices located at 1320 Washington Avenue, Cleveland, Ohio 44113, (the Provider"), Provider to provide supportive housing for homeless, chemically dependent men residing at 2100 Lakeside Avenue, effective November 1, 2012, Cuyahoga County Contract No. CE - 1200657-01.

WITNESSETH:

WHEREAS, in order to continue to provide supportive housing for homeless, chemically dependent men residing at 2100 Lakeside Avenue, an amendment to the aforementioned Contract Agreement is necessary:

NOW, THEREFORE, the following amendments to the aforementioned Contract Agreement are agreed to by and between the parties hereto, as follows:

1. Except as herein specifically amended, all terms and provisions contained in the parent Contract are hereby ratified, confirmed, and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

2. The term of the contract is to be extended to June 30, 2014 .


3. The amount of the contract is to be increased by \$195,000.00 .

4. By entering into this Contract, I agree on behalf of the Provider, it's Officers, Employees, Subcontractors, Subgrantees, Agents or Assigns, to conduct this transaction by electronic means by agreeing that all documents requiring County signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

IN WITNESS WHEREOF, the County and the Provider have executed this Agreement.


