PURCHASE OF SERVICE CONTRACT WITH CENTER FOR FAMILIES AND CHILDREN

AMENDMENT NO. 2

THIS CONTRACT AMENDMENT made and entered into this _____ day of _____, 2013 by and between the County of Cuyahoga, Ohio (the "County"), and <u>Center for Families and Children</u>, with principal offices located at <u>4500 Euclid Avenue</u>, <u>Cleveland</u>, <u>Ohio 44103</u> (the "Provider").

WITNESSETH:

WHEREAS, in order to continue to provide the Families and Fathers Together (FAFT) Program, amendments to Contract Encumbrance No. CE1100498-01 are necessary:

THEREFORE, the following amendments to the aforementioned Contract are agreed to by and between the parties hereto, as follows:

- 1. That the reason for this amendment is to extend the period of performance and to amend the contract amount to provide for the continuation of services.
- 2. That Paragraph I (Term) is hereby amended by extending the end date of the contract from <u>June 30, 2013</u> to <u>June 30, 2014</u>.
- 3. That the amount of the contract is amended by \$96,000.00.
- 4. That the costs incurred for salaries and fringe benefits are amended by \$50,678.00.
- 5. That the costs incurred for consultation fees and operational costs are amended by \$16,330.00.
- 6. That the number of enrollments is amended by 48 times \$90.00 for \$4,320.00.
- 7. That the number of workshop completions is amended by <u>40</u> times <u>\$616.80</u> for \$24,672.00.

- 8. That Provider billings for services rendered during the term of the original contract, July 1, 2012 through June 30, 2013, shall not exceed the dollar value of the original contract. Provider billings for services rendered during the term of this amendment, July 1, 2013 through June 30, 2014, shall not exceed the dollar value of this amendment. Any unused funds from the original contract will not carry over into the period of this amendment.
- 9. That Applicable County Ordinances apply. All Contracts in which the County is a party, including this Contract, are subject to all applicable County Ordinances, including, but not limited to, the Cuyahoga County Ethics Ordinance, the Cuyahoga County Inspector General Ordinance and the Cuyahoga County Contracting and Purchasing Procedures Ordinance. During the term of this contract, including any extensions, all parties shall remain in compliance with all applicable County Ordinances and may access copies of all County ordinances on the Cuyahoga County Council's website at http://council.cuyahogacounty.us/
- 10. That the effective date of this amendment is July 1, 2013.

All other "Terms and Conditions" and EXHIBITS of the aforementioned Contract Agreement remain as originally written.
