

AMENDMENT TO CONTRACT

This Amendatory Contract made and entered into this _____ day of _____, 2011 between the CUYAHOGA COUNTY, OHIO (the "County") on behalf of the <u>Department of Development</u> and the <u>City of Lakewood</u>, a Political Subdivision, with the principal offices located at 12650 Detroit Avenue (the "Provider").

WITNESSETH:

WHEREAS, the County and the Provider entered into a Contract #AG0900048-01 dated July 1, 2009 (hereinafter called the "Contract") whereby the Provider was awarded \$200,000 in funds an activity entitled Mixed Use Rental Assistance Loan Program and

WHEREAS, the Contract was Amended November 3, 2010 by resolution 104817 to read \$25,000

WHEREAS, the amount of the Amended Contract reads \$25,000, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Provider hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. The date of $\frac{6/30/2011}{2011}$ appearing in Item II of the Contract shall be and is hereby changed to $\frac{12/31/2011}{2011}$
- 3. Approved Budget Budgetary Details shall be and is hereby changed and is attached hereto, as if fully rewritten herein to reduce the funding by \$5,000 effective September 14, 2011.
- 4 Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.
