

AMENDMENT TO CONTRACT

Dated October 1, 2010

By and Between

COUNTY OF CUYAHOGA

and

CITY OF EUCLID

This Amendatory Contract made and entered into this 1st day of April, 2011 by and between the County of Cuyahoga, Ohio (the "County"), and the Department of Development, and the City of Euclid, a political subdivision of the State of Ohio, with principal offices located at 585 East 222nd Street, Euclid, Ohio 44123, (the "Provider").

WITNESSETH:

WHEREAS, the County and the <u>City of Euclid</u> entered into an Contract # <u>AG1000313-01, 02</u> dated <u>October 1, 2010</u> (hereinafter called the "Contract") whereby the <u>City of Euclid</u> was awarded \$235,000 in funds for an activity entitled <u>Rehabilitation and Resale of Single-Family Homes</u> and

WHEREAS, the Contract expires on December 31, 2012 and

WHEREAS, the amount of the Contract reads \$235,000, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the City of Euclid hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. Approved Budget Budgetary Details shall be and is hereby changed to add additional FY2008 HOME funds not to exceed the amount of \$105,966 to the budget, which increases the contract Amount from \$235,000 to \$340,966 effective April 1, 2011
- 3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

By entering into this (agreement/contract/amendment to agreement or contract) or (by submitting a bid) or (by submitting a proposal) I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, sub-grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapters 304 and 1306 of the Ohio revised code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County
