



AMENDMENT TO AGREEMENT NO. AG1100178

and

This Amendatory Agreement made and entered as of _____ 20__ by and between COUNTY OF CUYAHOGA, OHIO, (the "County"), on behalf of the Department of Development ("DOD"), and the City of Shaker Heights, a political subdivision of the State of Ohio, with principal offices located at 3450 Lee Road, Shaker Heights, Ohio 44120 (the "City").

WITNESSETH:

WHEREAS, the County and the City of Shaker Heights, a political subdivision of the State of Ohio, entered into an Agreement # AG1100178-01 dated October 19, 2011 (hereinafter called the "Agreement") whereby the City of Shaker Heights was awarded \$57,300 in funds for an activity entitled NSP 1 Demolition and

WHEREAS, the Agreement expires on October 27, 2012 and;

WHEREAS, the amount of the Agreement as amended reads \$65,550, and;

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the City of Shaker Heights hereby agree as follows:

1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Agreement.
2. The date of October 27, 2012 appearing in Item II of the Agreement shall be and is hereby changed to January 31, 2013.
3. Except as herein specifically amended, all of the terms and provisions contained in the Agreement are hereby ratified and confirmed and said Agreement is hereby incorporated to the same extent as if fully rewritten herein.

All county Contracts/Agreements and amendments are subject to all applicable County ordinances, including, but not limited to, the Cuyahoga County Ethics Ordinance, Cuyahoga County Inspector General Ordinance, and Cuyahoga County Board of Control, Contracting and Purchasing Ordinance, and the successful bidder shall comply with all such ordinances as an integral part of all County contracts.


