This Amendatory Agreement made as of \_\_\_\_\_ day of \_\_\_\_\_, A.D., 2013 between the Cuyahoga County Executive, (hereinafter referred to as the "County"), on behalf of the Cuyahoga County Corrections Planning Board (hereinafter referred to as the "Corrections Board") and the Cuyahoga County Common Pleas Court (hereinafter referred to as the "Court") and the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County a county office located at 2012 West 25<sup>th</sup> Street, 6<sup>th</sup> Floor Cleveland, Ohio 44113-3102 (hereinafter referred to as the "ADAMHS Board"), for substance abuse treatment services in a residential setting.

**Witnesseth:**

**Whereas**, the County and the ADAMHS Board entered into an Agreement (Resolution R2012-0038) (hereinafter called "Agreement") whereby the ADAMHS Board was awarded \$1,780,395.00 in funds for an activity entitled Residential Treatment Services for Offenders Supervised by the Adult Probation Department, and

**Whereas**, the County and the ADAMHSB entered into an Amendatory Agreement (Board of Control Resolution BC2012-208) dated July 30, 2012 (hereinafter called "First Amendment Agreement") whereby the Alcohol, Drug Addiction and Mental Health Services Board of Cuyahoga County, was awarded an additional \$118,000.00 in funds for an activity entitled Residential Treatment Services for Offenders Supervised by the Adult Probation Department; and

**Whereas**, the amount of the First Amendment Agreement reads:

**\$1,898,395.00 for the period January 1, 2012 through December 31, 2014**, and

**Now, therefore**, in consideration of the mutual covenants and contracts herein contained, the County and the ADAMHS hereby agree as follows:


1. Except as herein specifically amended, all terms used herein have the same meanings in the Agreement.
2. The total amount of the contract should read \$2,198,530.00 for the period January 1, 2012 through December 31, 2014. The amount of the Agreement is increased by \$300,135.00 to \$893,600.00, to add additional funds to the contract. This amendment is necessary so that the ADAMHS Board may provide additional inpatient slots for dually diagnosed offenders (\$300,135.00). The additional funding is provided by the Ohio Department of Rehabilitation and Correction's Probation Improvement Grant and Cuyahoga County General funds.
3. Except as herein specifically amended, all of the terms and provisions contained in the Contract and the first Contract amendment are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.


