Amendment to Agreement # AG 1200164 entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013, by and between the County of Cuyahoga, Ohio (the "County"), on behalf of the Office of Early Childhood ("OEC") and The Cuyahoga County Board of Health ("Provider"), a county agency, with principal offices located at 5550 Venture Avenue, Parma, Ohio 44130 for the purpose of amending the contract by making the changes as follows:

**1. Amending Section I. SCOPE OF SERVICE: Section A. CORE COMPONENTS effective February 1, 2013 # 5 to read:**

Conduct **1,930 newborn home visits** to assess the health of the baby and care giving skills of the mother. A completed home visit will consist of the actual home visit plus a completed follow up phone call or three (3) follow up phone call attempt and a completed or attempted Newborn Behavioral Observation (NBO).

**2. Amending Section II. TERMS OF SERVICE to read:**

Extending the time from **April 1, 2012** through **January 31, 2013 to December 31, 2013.**

**3. Amending Section III, CONTRACT VALUE to read:**

This amendment shall total **\$453,000.00** from an aggregated contract award amount of **\$553,000.00 to \$1,006,000.00**. Total expenditures shall be limited to the aggregated amounts by account/program area as outlined in the revised **Exhibit I** (attached)

**4. All other terms of the contract are hereby reaffirmed.**

**5. IN WITNESS WHEREOF**, the County and the Cuyahoga County Board of Health have entered into this contract amendment as of the day and year first written above.



BY ENTERING INTO THIS CONTRACT AMENDMENT, I AGREE ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT.**

I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.
