

INTERAGENCY AGREEMENT AMENDMENT

This amendment is entered into on this _____ day of _____, 2013 by and between the Cuyahoga County, Ohio on behalf of Family & Children First Council, hereinafter referred to as (County) and the Educational Service Center of Cuyahoga County, a political subdivision of the state governed by Ohio School Law, with principle offices located at 5811 Canal Road, Valley View, Ohio 44126 (216) 524-3000 (hereinafter referred to as the "AGENCY"). The COUNTY and the Educational Service Center shall be individually referred to as a "PARTY" and jointly referred to hereinafter as the "PARTIES".

WHEREAS, the AGENCY was awarded RQ 24978 to be the fiscal agent for Families and School Together, Parent as Teachers (Bright Beginnings), and the Parent Advocacy and Leadership Coalition.

WHEREAS, the AGENCY is responsible for the region which includes 31 school districts and two vocational learning institutions within Cuyahoga County.

WHEREAS, an amendment to Contract number AG1200285-01 is necessary and the PARTIES hereto, mutually agree as follows:

NOW, THEREFORE, the Parties agree as follows:

1. To amend the interagency agreement to add funding for the remainder of the agreement, which is dated July 1, 2012 to September 30, 2014. Additional funding in the amount of \$714,930.00 to cover the cost of program operations through the end of the agreement. The initials of the AGENCY below show acknowledgement.

The total amount of the interagency agreement cannot exceed ~~\$1,407,860.00~~ over the life of this interagency agreement. If the amount of the invoices exceeds the amount of the interagency agreement, the AGENCY realizes that no additional funds will be paid over and above the total amount of the interagency agreement, under any circumstances, even if additional services are provided.
