

**AMENDMENT TO AGREEMENT BETWEEN
CUYAHOGA COUNTY, OHIO ON BEHALF OF THE COUNTY SHERIFF'S
DEPARTMENT AND
THE METROHEALTH SYSTEM
FOR THE PROVISION OF MANAGEMENT, HEALTHCARE AND RELATED
SERVICES**

This Amendment (this "Amendment") is entered into effective as of the 28th day of February, 2014 by and between the County of Cuyahoga, Ohio, on behalf of the Cuyahoga County Sheriff's Department located at 1215 West 3rd Street, Cleveland, Ohio 44113 ("CCSD"), and The MetroHealth System, a county hospital organized and operated by its board of county hospital trustees under Chapter 339 of the Ohio Revised Code, located at 2500 MetroHealth Drive, Cleveland, Ohio 44109 ("MetroHealth").

RECITALS:

1. CCSD and MetroHealth entered into a certain Agreement between Cuyahoga County, Ohio on behalf of the County Sheriff's Department and The MetroHealth System for the Provision of Management, Healthcare and Related Services dated effective January 1, 2014, for MetroHealth to provide certain Professionals and Services, as those terms are defined therein (the "Original Agreement").

2. CCSD and MetroHealth desire to amend the Original Agreement to extend the term on the same terms and subject to the same conditions as set forth in the Original Contract.

NOW, THEREFORE, in consideration of the promises and mutual obligations contained herein and in the Original Agreement, CCSD and MetroHealth hereby agree as follows:

1. **Amendment.** This Amendment amends the Original Agreement and, except as specifically amended hereby, the Original Agreement shall remain in full force and effect. The Original Agreement, together with this Amendment are herein collectively referred to as the "Agreement".

2. **Term.** Section I is hereby amended by extending the term of the Agreement for an additional month so that the term of the Agreement is three (3) months, commencing on January 1, 2014 and terminating on March 31, 2014.

3. **Amendment Shall Control.** In the event that a discrepancy exists between the terms of this Amendment and the Original Agreement, this Amendment shall control.


4. **Electronic Signature.** METROHEALTH AGREES ON ITS BEHALF AND ON BEHALF OF ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, THAT ALL CONTRACT DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE

DOCUMENT. THE CONTRACTOR ALSO AGREES ON BEHALF OF THE AFOREMENTIONED ENTITY AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.


