

**Amendment to Contract**

THIS AMENDMENT (hereinafter referred to as the "Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2011, by and between Cuyahoga County, Ohio ("the County"), on behalf of the Cuyahoga County Information Services Center / BOE and **Sprint Solutions, Inc., ("Sprint")**, a Delaware corporation with principal offices at 6500 Sprint Parkway, Overland Park, KS 66251 (the "Sprint")

WHEREAS, the County and Sprint entered into Contract CE0800616, for Sprint to provide the Board of Elections "Push to Talk" Election Day Communication Service; and

WHEREAS, the County desires to again extend the term of its Contract with Sprint, for one year, until June 30, 2011; and

WHEREAS, the funds originally encumbered at the time of the Contract are sufficient to cover the extension contemplated by this Amendment so no additional funds are necessary; and

WHEREAS, County desires to amend the Contract thereby extending the Contract until June 30, 2011; and

WHEREAS, the County require adherence to the County's Electronic Signature Policy; and

WHEREAS, the County and Sprint have mutually agreed that changes are necessary to the terms and provisions contained in the original Contract.

The Contract is hereby amended as follows:

**I – AGREEMENT AND TERM**

- A. The Contract, as amended, shall be extended until June 30, 2011 at no additional cost. Extension of Term. The parties hereby agree that the Term of the Contract as set forth in Section 1.2 of the Contract, is hereby **extended until June 30, 2011.**

## **II -- ADHERENCE TO ELECTRONIC SIGNATURE POLICY OF COUNTY**


- A. By entering into this Contract, Sprint, its officers, employees, subcontractors, sub-grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by Cuyahoga County to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document.
- B. Sprint further agrees to be bound by the provisions of Chapter 304 and 1306 of the Ohio Revised Code as they pertain to Electronic Transactions and to comply with the electronic signature policy of Cuyahoga County.

**All other terms and conditions of the original contract which are not expressly modified herein shall remain in full force and effect.**
