ODYS STEP-DOWN PROGRAM SERVICES AGREEMENT

THIS AMENDMENT is entered into this _____ day of _____, 2011 by and between the County of Cuyahoga, Ohio (hereinafter called the "COUNTY"), the Cuyahoga County Juvenile Court (hereinafter called the "COURT") and **Catholic Charities Services Corporation dba Parmadale**, a non profit organization a corporation not-for-profit, with principal offices located at 6753 State Road, Parma, Ohio 44134-4596, Federal _____ (hereinafter called the "VENDOR").

WITNESS THAT:

WHEREAS, the COUNTY and the COURT desire to engage the VENDOR'S professional and technical services to assess, treat and rehabilitate youth who have been sentenced to the Ohio Department of Youth Services as part of the **ODYS Step-down Program**, and the VENDOR shall provide these services from January 1, 2009 to August 31,2010 for the COURT.

NOW, THEREFORE, it is agreed that the agreement by and between the COURT and the VENDOR for services is hereby amended to include the following revision to sections:

1. To increase the funds in the amount of \$34,854.52. This changes the value of the contract from \$66,810.00 to \$101,664.52.
2. ELECTRONIC SIGNATURES - By entering into this AGREEMENT, the VENDOR agrees on behalf of the contracting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means and that the electronic signatures affixed by the COUNTY to said documents shall have the same legal effect as if the signature was manually affixed to a paper version of the document. The VENDOR also agrees on behalf of the aforementioned entities and persons to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County

All other sections of the original contract shall remain the same.

IN WITNESS WHEREOF, the COUNTY, the COURT and the VENDOR have executed this AMENDMENT as of the date first above written.
