  - a. Transferring funds in the amount of \$4,000.00 from Program Costs to Reduced Fees for Households
  - b. Adding additional funds in the amount of \$23,481,00 to Reduced Fees for Households for an aggregate amount of \$130,373.56 for the 2010-2011 program year only. The total is allocated as follows:
    - \$74,892.56 not to exceed amount for UPK Program costs.
    - \$55,481,00 Reduced Fees for Households.
- 2. By entering into this contract amendment, I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronics means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
- 3. All other terms of the contract are hereby reaffirmed.
- 4. The County and the Provider have entered into this contract as of the day and year first written above.
