- 1. Amending Article 3 "CONTRACT VALUE AND RATE OF PAYMENT" to increase the value of the contract and to change the second paragraph to read as follows:
 - a. Increasing the value of the contract by \$7,000.00 for an aggregate contract amount of \$199,873.67 for 2009-2012.

The total amount available for the 2011-2012 program year shall be \$79,828.00 and is allocated as follows:

- 51,190.00 not to exceed amount for UPK Program costs.
- \$28,638.00 Reduced Fees for households with incomes up to 400% of the federal poverty limit (FPL) based on the 2011 Federal Poverty Level Guidelines as published in the Federal Register in January 2011; this amount is allocated for use exclusively to cover 33% of eligible parents reduced fees.
- 2. By entering into this contract amendment, I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronics means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
- 3. All other terms of the contract are hereby reaffirmed.
- 4. The County and the Provider have entered into this contract as of the day and year first written above.
