

AMENDMENT TO CONTRACT

By and Between

CUYAHOGA COUNTY OF OHIO

and

CITY OF SHAKER HEIGHTS

This Amendatory Contract made and entered into this _______ day of ______, 2011 by and between County of Cuyahoga, Ohio, Cuyahoga County, Ohio (the "County"), on behalf of the Department of Development and the <u>City of Shaker Heights</u>, a political subdivision with principal offices located at 3400 Lee Road, Shaker Heights, Ohio 44120, (the "Political Subdivision").

WITNESSETH:

WHEREAS, the County and the Political Subdivision entered into an Contract # CE0900765-01 dated June 1, 2009 to December 31, 2010 (hereinafter called the "Contract") whereby the Political Subdivision was awarded \$100,000 in funds an activity entitled City Building ADA Improvements; and

WHEREAS, the Contract expires on **December 31, 2010**; and

WHEREAS, the amount of the Contract reads \$100,000; and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Political Subdivision hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. The date of <u>December 31, 2010</u> appearing in Item II of the Contract shall be and is hereby changed to <u>June 30, 2011.</u>
- 3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

This Contract may be executed in four copies, each of which shall constitute an original, but when taken together shall constitute but one Contract.

IN WITNESS WHEREOF, the County and Political Subdivision have caused this Amendment to Contract to be executed the day, month and year first above written.

By entering into this contract I agree on behalf of the contracting entity, its officers, employees, subcontractors, sub grantee, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring the county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effects as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapter 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
