

AMENDMENT TO CONTRACT

Dated October 1, 2009

By and Between

CUYAHOGA COUNTY, OHIO

and

Emerald Development and Economic Network, Inc.

This Amendatory Contract made and entered into this _____ day of _____, 2011 by and between the County of Cuyahoga, Ohio (the "County"), on behalf of the, <u>Department of Development</u>, and the <u>Emerald Development and Economic Network, Inc.</u>, a corporation not-for-profitwith principle offices located at <u>7812 Madison Avenue</u>, <u>Cleveland</u>, <u>Ohio 44102</u> (the "Provider").

WITNESSETH:

WHEREAS, the County and the Provider entered into an Contract # <u>CE1000152-01</u> dated <u>October 1, 2009</u> (hereinafter called the "Contract") whereby the Provider was awarded \$400000 in funds an activity entitled <u>Tenant Based Rental Assistance</u> and

WHEREAS, the Contract was Amended on December 2, 2010 by resolution 105131 to add \$200,000

WHEREAS, the amount of the Amended Contract amount totals \$600,000, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Provider hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. The date of <u>August 31, 2011</u> appearing in Item II of the Contract shall be and is hereby changed to <u>October 31, 2011</u>.
- 3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

By entering into this (agreement/contract/amendment to agreement or contract) or (by submitting a bid) or (by submitting a proposal) I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, sub-grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapters 304 and 1306 of the Ohio revised code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County
