

#### AMENDMENT TO CONTRACT

Dated March 11, 2010

By and Between

CUYAHOGA COUNTY, OHIO and

Ciuni & Panichi, Inc.

THIS AMENDATORY CONTRACT made and entered into this <u>21st</u> day of <u>November</u>, 20<u>11</u> by and between Cuyahoga County, Ohio (the "County"), on behalf of the <u>Department of Development</u> and <u>Ciuni & Panichi</u>, <u>Inc.</u>, a corporation, with principal offices located at <u>25201 Chagrin Boulevard</u>, <u>Beachwood</u>, <u>Ohio 44122</u> (the "Provider").

#### WITNESSETH:

WHEREAS, the County and the Provider entered into Contract # CE1000218-01 dated March 11, 2010 (hereinafter called the "Contract") whereby the Provider was awarded not to exceed \$100,000 in funds for an activity entitled <a href="Davis-Bacon Compliance Assistance">Davis-Bacon Compliance Assistance</a> and

WHEREAS, the Contract expires on December 31, 2012 and

WHEREAS, the amount of the Contract reads not to exceed \$100,000, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Provider hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. Attachment 1-Budgetary Details shall be and is hereby changed to increase the amount budgeted for Contractual from \$100,000 to 130,256.25, effective November 21, 2011.
- 3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

IN WITNESS WHEREOF, the County and the Provider have caused this Amendment to Contract to be executed the day, month and year first above written.
