

**Amendment to Contract
CE 1000314-01
by and between
Cuyahoga County
and
OneLink Technical Services, LLC**

THIS AMENDMENT (hereinafter referred to as the "Amendment") is made and entered into this _____ day of _____, 2011, by and between Cuyahoga County, Ohio ("the County"), on behalf of the Cuyahoga County Office of Procurement & Diversity and **OneLink Technical Services, LLC**, ("OneLink"), with a principal place of business located at 875 Westpoint Parkway, Westlake, Ohio 44145. (the "Provider")

WHEREAS, the County and OneLink entered into Contract No. CE1000314-01, for Professional Consulting Services to implement and maintain Hyland's OnBase Software Licensing for the period 4/16/2010 – 8/27/2011; and

WHEREAS, the County and OneLink entered into a contract amendment to CE1000314-01, increasing the scope of work; and

WHEREAS, the County and OneLink entered into a subsequent amendment for the purpose of increasing licensing and maintenance, by changing the terms effective 4/16/2010 and for additional funds; and

WHEREAS, the County desires to amend the term of its Contract with OneLink, to establish the software warranty period effective 8/1/2011 – 7/31/2012 with no additional funds required; and

WHEREAS, this Amendment will not cause an increase in the "not to exceed price" of the Contract as previously amended. The current "not to exceed price" shall be, One Hundred Forty Nine Thousand Five Hundred Sixteen Dollars and Ninety Cents; and

WHEREAS, the County and OneLink have mutually agreed that changes are necessary to the terms and provisions contained in the original Contract.

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, OneLink and the County agree as follows that the original contract as previously amended shall be further amended as follows:



I – AGREEMENT AND TERM

A. This Contract, as amended, shall establish the software warranty period effective 8/1/2011 – 7/31/2012. The current "not to exceed price" of One Hundred Forty Nine Thousand Five Hundred Sixteen Dollars and Ninety Cents will not be increased; and


All other terms and conditions of the original contract and prior amendment thereto, which are not expressly modified herein, shall remain in full force and effect.
