

AMENDMENT TO CONTRACT

This Amendatory Contract made and entered into this _____ day of _____, 2011 by and between County of Cuyahoga, Ohio, Cuyahoga County, Ohio (the "County"), on behalf of the Department of Development and the <u>City of Maple Heights</u>, a political subdivision with principal offices located at **5353 Lee Road, Maple Heights**, Ohio **44137**, (the "Political Subdivision").

WITNESSETH:

WHEREAS, the County and the Political Subdivision entered into an Contract # <u>CE1000468-01</u> dated <u>May 1, 2010 to November 30, 2011</u> (hereinafter called the "Contract") whereby the Political Subdivision was awarded <u>\$100,000</u> in funds an activity entitled <u>Granger Road Reconstruction</u> and

WHEREAS, the Contract expires on November 30, 2011 and

WHEREAS, the amount of the Contract reads \$100,000, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Political Subdivision hereby agree as follows:

- 1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
- 2. The date of November 30, 2011 appearing in Item II of the Contract shall be and is hereby changed to May 31, 2012.
- 3. The Project Activity Description appearing in Schedule A of the Contract shall be and is hereby changed to REVISED Schedule A.
- 4. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

By entering into this contract I agree on behalf of the contracting entity, its officers, employees, subcontractors, sub grantee, agents or assigns, to conduct this transaction by

electronic means

by agreeing that all documents requiring the county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effects as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapter 304 and 1306 of the Ohlo Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
