This Amendatory Contract made as of _____ day of _____, A.D., 2011 by and between the County of Cuyahoga, Ohio (hereinafter "**County**"), on behalf of the Cuyahoga County Common Pleas Court and the Cuyahoga County Corrections Planning Board (hereinafter "**Court**") and Cuyahoga County Community Corrections Association (4CA), Inc., a corporation not-for-profit, with principal offices located at 1710 Prospect Avenue, Cleveland, Ohio 44115 (hereinafter "**4CA**") acting as fiscal agent for participating halfway house agencies within Cuyahoga County for offender halfway house substance abuse services.

Witnesseth:

Whereas, the County and the 4CA entered into a Contract (County Resolution 103232) dated August 5, 2010 (hereinafter "**Contract**") whereby the 4CA was awarded \$628,400.00 in funds for an activity entitled Residential Halfway House Substance Abuse Treatment Program for Offenders Supervised by the Adult Probation Department, and

Whereas, the amount of the Contract reads:

\$628,400.00 for the period July 1, 2010 through June 30, 2011, and

Now, therefore, in consideration of the mutual covenants and contracts herein contained, the County and the 4CA hereby agree as follows.


1. Except as herein specifically amended, all terms used herein have the same meanings in the Contract.
2. The time period of the contract shall be extended to June 30, 2014 with no increase in funding. The Contract shall read **\$628,400.00 for the period July 1, 2010 through June 30, 2014**. This amendment is necessary so that the 4CA may continue to provide residential substance abuse treatment services to additional offenders placed into treatment programs by order of the court where alternate funding is not available.
3. Except as herein specifically amended, all of the terms and provisions contained in the Contract and the first Contract amendment are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.
