MODIFICATION/CHANGE #1

ARTICLE II -TERMS OF SERVICE:

To revise the Terms of Service contained in the original contract to reflect the following:

The initial term of this contract was July 1, 2010 through June 30, 2012. This amendment will discontinue the provision of Homemaker Services (HMK) on May 1, 2011. The term of this contract for all other services remains the same.

Subject to the limitations specified in Article III, the amount to be paid for purchased services pursuant to the terms and conditions of this agreement will be based on the following unit rate(s) and/or fixed rate structure for the duration of this agreement. The Provider agrees to provide the following service units per service code subject to the limitations specified by the unit rate.

UNDER NO CIRCUMSTANCES SHALL DSAS REIMBURSE THE PROVIDER MORE THAN **\$25,642.00** WHICH IS THE TOTAL OF THIS CONTRACT AMENDMENT.

ARTICLE XXIII - ELECTRONIC TRANSACTION:

By entering into this Contract, I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by the County to said documents shall have the same legal effect as it that signature was manually affixed to a paper version of the document.
